SUBJECT:	Award of Contract No. 1724-001-11 Major Road Network Paving		

## RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract No. 1724-001-11 to Mainland Construction Material ULC dba Winvan Paving in the amount of \$4,635,855.00 (including GST), for Major Road Network Paving at various locations;
- 2. Set the expenditure authorization limit for Contract No. 1724-001-11 at \$5,100,000.00 (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1724-001-11.

# INTENT

The intent of this Corporate Report is to seek Council's approval to award a contract for the Major Road Network Paving.

## DISCUSSION

## Scope of Work

The construction package related to this contract consists of repaving of 25.0 lane-km of Major Road Network ("MRN") roads to maintain a state of good repair. The locations are listed in the following table and are also illustrated on the map attached to this report as Appendix "I":

The contract permits construction from 7:00 a.m. to 10:00 p.m., Monday through Friday, in compliance with the *Surrey Noise Control Bylaw*, *1982*, *No.* 7044. The contract includes nighttime paving in certain locations to avoid major traffic congestions.

## **Invitation to Tender Results**

Tenders for the subject contract were opened on December 21, 2023 with the following results:

The Engineer's (R.F. Binnie & Associates Ltd.) pre-tender estimate was \$5.4 million (including GST).

## Evaluation

The submissions were reviewed for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed on the Tender Form.

The low bidder, Mainland Construction Material ULC dba Winvan Paving ("Winvan"), has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 80 working days, as stipulated in the contract. Winvan's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Winvan be awarded Contract No. 1724-001-11.

## **Project Schedule**

The contract work is expected to start in April 2024, and be completed by August 2024.

## FUNDING

Funding for this Contract is available in the approved 2024 Transportation Budget.
