SUBJECT:	Sponsorship Request – Surrey Hospitals Foundation		

RECOMMENDATION

The Finance Department recommends that Council:

- 1. Receive this report for information; and
- 2. Approve from the Council Initiatives Fund, a sponsorship contribution of \$12,500 to Surrey Hospitals Foundation (the "Foundation") in support of their 7th Annual Celebration of Care Gala.

INTENT

The City has received a request from the Surrey Hospitals Foundation to support their 7th Annual Celebration of Care Gala that will be held on Saturday, February 24th, 2024, at the Aria Convention Centre in Surrey.

DISCUSSION

The Foundation is a registered charity and the largest non-government funder of health care for families in Surrey. The Foundation supports the ongoing priorities identified by major health care facilities including, Czorny Alzheimer Centre, Jim Pattison Outpatient Care and Surgery Centre and Surrey Memorial Hospital. The Celebration of Care is an annual fundraising event that attracts hundreds of Surrey's business, community, and medical luminaries. The Celebration of Care Gala is all about providing life-changing health care for Surrey and its surrounding communities. On February 24, 2024, the Foundation will be hosting their 7th Annual Celebration of Care Gala in Surrey. All funds raised at the Gala will directly support specialized medical equipment for the first-ever catheterization labs being built at Surrey Memorial Hospital, as well as ongoing and future cardiac care needs.

The Foundation is requesting that the City consider supporting the Celebration of Care Gala this year by becoming a Gold Sponsor and providing a contribution of \$12,500. With this sponsorship, the City will receive a table with ten complimentary tickets to the event. The tickets will be allocated to the members of Council who plan to attend the event. The City will be recognized as a sponsor and supporter of the event and the City logo will be included in the event's program, on the Foundation's website, social medial platforms, and on the venue's digital screens. Full details of the sponsorship opportunities are attached in Appendix "I".

FUNDING

Staff have evaluated the request to ensure it is compliant with the Council Initiatives Fund Utilization Policy. Staff recommend that Council support the Foundation's 7th Annual Celebration of Care Gala through a sponsorship of \$12,500 from the Council Initiatives Fund. Appendix "II" attached to this report documents the balance in the Council Initiatives Fund based on an assumption that Council will approve the recommendations of this report.

CONCLUSION

Based on the aforementioned discussion, it is recommended that Council approve from the Council Initiatives Fund, a sponsorship contribution of \$12,500 to Surrey Hospitals Foundation in support of their 7th Annual Celebration of Care Gala.
