SUBJECT: Award of Contract No. 1220-040-2024-005

Tennis Court Lighting Upgrades at Newton Athletic Park

#### RECOMMENDATION

The Parks, Recreation, & Culture Department recommends that Council:

- 1. Receive this report for information;
- 2. Award Contract No. 1220-040-2024-005 to Boileau Electric and Pole Line Ltd. in the amount of \$459,805.50, including GST, for upgrades to the tennis court lighting system at Newton Athletic Park; and
- 3. Authorize the General Manager, Parks, Recreation & Culture, to execute Contract No. 1220-040-2024-005 to a maximum of \$505,786.05, including GST and contingency.

#### **INTENT**

The purpose of this report is to obtain Council's approval to award Contract No. 1220-040-2024-005 for the LED upgrades to the tennis court lighting system at Newton Athletic Park.

#### **DISCUSSION**

#### Scope of Work

The scope of work related to this contract consists of the installation of nine new light poles and the upgrade of electrical infrastructure and fixtures to support a conversion to high efficiency LED lighting on the existing tennis court complex.

### **Request For Quotation Results**

In January 2024, a Request for Quotation ("RFQ") was issued for the LED upgrade of the tennis court lighting system at Newton Athletic Park. Detailed design drawings, specifications, and tender documents for the work were prepared by DMD & Associates Electrical Consultants Ltd. and included in the RFQ.

RFQ submissions for the subject contract were received from five Contractors and were opened on February 2, 2024 as follows:

#### **Evaluation**

The evaluation included consideration of previous and recent performance on projects of a similar scale and nature, proponents' financial stability, product technical evaluation (including warranty provisions), understanding of project scope, demonstrated capability to deliver on project objectives, schedule, and financial submission.

The best value submission is from Boileau Electric and Pole Line Ltd. They have no outstanding legal claims against the City. It is recommended that Boileau Electric and Pole Line Ltd be awarded Contract No. 1220-040-2024-00.

This report has been reviewed by Legal Services.


