SUBJECT:	Contract Award M.S. 4801-012-00 – Chet Construction Ltd.		

RECOMMENDATION

That Contract M.S. 4801-012 be awarded to the low bidder, Chet Construction Ltd., in the amount of \$1,518,142.91 including GST.

SCOPE OF WORK

Contract M.S. 4801-012 involves the following:

- Construction of a storm water detention pond and wetland, along with various park features including a parking lot, playfield and landscaping at 154 Street and 103A Avenue.
- Optimization of existing storm water detention ponds and control structures along the 96 Avenue hydro right-of-way between 153A and 159 Street.
- Tunnelling and construction of 100 metres of storm sewers at 116 Avenue and 140 Street.
- Tunnelling and construction of 80 metres of storm sewer under King George Highway at Bolivar Road.
- Construction of approximately 1,500 linear metres of dyke on the Serpentine River.

Construction is expected to start by May 14, 2001, and be completed by October 31, 2001.
