RECOMMENDATION

That Contract M.S. 1701-007 be awarded to the low bidder, Aggressive Roadbuilders Ltd., in the amount of \$1,583,733.75, including GST.

SCOPE OF WORK

The scope of work under this contract includes intersection improvements, traffic and pedestrian signals, sidewalks and pathways at 15 different locations as shown on Appendix I, attached Construction is expected to start July 9, 2001, and be completed by November 15, 2001.

TENDER RESULTS

Tenders for Contract M.S. 1701-007 were received on June 14, 2001, with the results as follows:

Contractor Tender Amount with GST

- 1. Aggressive Roadbuilders Ltd. \$1,583,733.75
- 2. TAG Construction Ltd. \$1,598,494.94
- 3. B&B Contracting Ltd. \$1,673,104.26
- 4. Imperial Paving Ltd. \$1,778,785.12

The Engineer's pre-tender estimate was \$1,602,000 including GST.

EVALUATION

All tenders were reviewed by our consultant. They found no arithmetical errors and all the tenderers submitted the required 10% bid bond and signed and sealed the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Aggressive Roadbuilders Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work in 90 days as stipulated in the contract. Aggressive, and their sub-contractors, have satisfactorily completed many similar projects for the City in the past and we have found them to be acceptable.

FUNDING

Funding requirements are as follows:

Total Funding Required \$1,921,000 Total Funding Available \$1,660,000 Shortfall \$ 261,000

The shortfall of \$261,000 is available in the Roads Unallocated budget.
