SUBJECT: Public Art Advisory Committee Report – April – June 2001

RECOMMENDATION

That Council receive this report for information.

BACKGROUND

The Public Art Policy for Surrey was adopted in principle on June 23, 1997 and confirmed as a City Policy No. R-21 on May 4, 1998 (R98-1293A). The Public Art Advisory Committee was officially appointed by City Council on October 13, 1998.

This report summarizes the activities of the Public Art Advisory Committee for the second quarter of 2001.

DISCUSSION

The Public Art Advisory Committee held three regular meetings in this quarter. These were on April 20, May 18 and June 15; notes from each meeting are attached. In addition to the meetings, the Committee and the Surrey Art Gallery worked in partnership with Kwantlen University College to host an exhibition of proposals and maquettes created in response to Calls to Artists for the City of Surrey Public Art Program. This exhibition was in place from April 2 - 26 and was well attended.

On June 15 the PAAC members were pleased to welcome the new Council appointee to the Committee, Vikram Singh. The Committee was also informed that the City Clerks office would like to adjust the term of PAAC appointments to end on December 31. The City Clerks office has requested that current PAAC members whose terms expire this year consent to extend their terms from the current expiration on October 15 to December 31, 2001.

Public Art Projects

Surrey Arts Centre Redevelopment

On April 15, Alan Storey, the selected artist for the Surrey Arts Centre project, met with the Diversity Advisory Committee to discuss opportunities for the community to be involved in the development of the artwork. Further consultation will take place with the First Nations community.

Crescent Beach Community Art Project

Tina Farmilo, the artist selected for the Crescent Beach Community Art Project received a favorable write up titled *Stones on a Roll* in the Peace Arch News on April 14. Ms. Farmilo has purchased 34 granite boulders; however, there is a delay in the project's completion date due to the community process taking longer than anticipated.

Street Banner Report and Standing Committee

On April 20, PAAC approved the amended Street Banner Sub-committee Terms of Reference to include five members on the committee, with three members forming quorum. On June 15, PAAC appointed Gerry Delagarza and Elizabeth Hollick to the Street Banner Selection Sub-committee. Gerry Delagarza was recommended from the Diversity Advisory Committee; Elizabeth Hollick is a well known artist in the community.

Greenways

On May 18, PAAC approved the Call to Artists to create a Greenways Art Plan. On June 15, PAAC approved the appointment of two people to be on the Selection Panel for this project : Amy Rybacki, Leap Artist Run Centre Association member and SFU student; and Don Luymes, Assistant Professor Community and Environment, UBC.

Quibble Creek Pump Station

On May 18, PAAC was notified that the artwork and a large louver were stolen from the pump station. On June 15, PAAC considered and approved the reconstruction budget and timeline for the Quibble Creek Pump Station Artwork, with funds received from the artwork's insurance. Changes in construction and installation are being considered to ensure that the artwork is secured from future vandalism or theft.

Fleetwood Booster Pump

On April 20 the PAAC approved the draft Call to Artists to create Public Art for the upcoming pump station located on Fleetwood Way and 90 Avenue. Subsequent to this meeting, staff were informed of a delay in the overall project schedule and held off in releasing the Call.

PUBLIC ART MASTER PLAN 2001 – 2003

At the April 20 meeting, PAAC approved the revised Public Art Master Plan to be forwarded to Council.

Public Art Policy Review, and Gifts, Donations and Bequests of Artwork – Acquisitions and De-accessioning Guidelines and Procedures

On June 15 the PAAC moved the updated Public Art Policy Review and the "Gifts, Donations and Bequests of Artwork – Acquisitions and De-accessioning Guidelines and Procedures" for Council's consideration. PAAC also expressed its appreciation to Lianne Payne, Public Art Coordinator, for the excellent work that was done in developing

the documents.

PAAC OBSERVER DEFINITION

On June 18 the PAAC reviewed and approved a description of the PAAC liaison role as an observer to selection panel meetings, for inclusion in Selection Panel Terms of Reference.

CONCLUSION

In the three years since Council approved the Public Art Policy, five projects have been completed. There are currently four projects underway and two Calls to Artists are currently active.

The Public Art Policy Review is an example of the diligent and mindful manner that PAAC demonstrates in carrying out their responsibilities.
