### RECOMMENDATION

That Council:

- 1. Approve the amendment to Schedule "A" of the Fee Schedule of Highway and Traffic By-law, 1997, No. 13007 (the "By-law"); and
- 2. Instruct the City Clerk to prepare and introduce the appropriate amending by-law replacing the existing schedule with the new schedule attached to this report.

### **BACKGROUND**

A complete review was conducted of the By-law as it related to the included penalty schedules and early payment of fines at a reduced rate. This review was done in conjunction with those fines imposed under the By-law. The operating and administration costs were compared to those penalties imposed under the By-law. The voluntary penalties set for payment under three days in some instances do not cover the costs incurred in processing the payment, (printing, postage, administration costs).

As a result of the review it is recommended that the time for early payment be extended from three days to seven days. The amounts for early payment have been adjusted to reflect costs. The additional time for early payment should result in greater early settlement of tickets and cash

flow.

### **DISCUSSION**

Other cities and municipalities have increased both their fine system and their voluntary penalties, which in all cases exceed the City of Surrey. These changes will not increase any of our fines or penalties, but will only affect the early payment schedule. In comparison, the City of Surrey has a minimum payment of \$14.00 and no other City has a minimum payment of less than \$20.00.

### **CONCLUSION**

It is recommended that Council approve the changes to Schedule "A" of the Highway and Traffic By-law, 1997, No. 13007.
