SUBJECT: Contract Award - M.S. 1702-004Winvan Paving Ltd.

RECOMMENDATION

That Contract M.S. 1702-004 be awarded to the low bidder, Winvan Paving Ltd., in the amount of \$1,198,659.31, including GST.

SCOPE OF WORK

The scope of work under this contract involves the construction of storm sewers, road works, sidewalks, asphalt pathways and other related works at various locations within the City of Surrey.

Construction is expected to start July 10, 2002, and be completed by October 4, 2002.

TENDER RESULTS

Tenders for Contract M.S. 1702-004 were received on June 20, 2002, with the results as follows:

Contractor Tender Amount with GST

1. Winvan Paving Ltd. \$1,198,659.31
2. Imperial Paving Ltd. \$1,262,624.61
3. Jack Cewe Ltd. \$1,308,721.55
4. Targa Contracting Ltd. \$1,426,814.58
5. CAP Ventures Ltd. \$1,466,814.58

The Engineer's pre-tender estimate was \$1,294,000 including GST.

EVALUATION

All tenders were reviewed by our consultant. They found that one tender did not contain a Schedule of Quantities and Prices and, therefore, the tender was considered incomplete. On the valid tenders, no mathematical errors were found and all the tenderers submitted the required 10% bid bond, and signed and sealed the Form of Tender and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 60 days as stipulated in the contract. Winvan Paving Ltd., and their sub-contractors, have satisfactorily completed many similar projects for the City in recent years and we have found them to be qualified and acceptable.
