SUBJECT:	Contract No. 1701-008-03: Fraser Highway Upgrading - Phase 2		

RECOMMENDATION

That Contract No. 1701-008-03 be awarded to the low bidder, Aggressive Roadbuilders Ltd., in the amount of \$3,723,632.10 including GST.

SCOPE OF WORK

The scope of work under this contract involves the upgrading of Fraser Highway between Fleetwood Way and 160 Street including the installation of water mains, storm sewers, underground telephone ducts, widening to 4 lanes, paving, curbs, sidewalks, street lights, traffic signals and landscaped medians.

Construction is expected to begin on October 15, 2002, and be completed by May, 2003.

TENDER RESULTS

Nine (9) tenders for this contract were received at City Hall on September 24, 2002. The results are as follows:

The Engineer's pretender estimate was \$4,425,200.

EVALUATION

All submitted tenders were reviewed by our consultant. They found minor mathematical errors which did not affect the order of the tenders and that all tenderers submitted the required 10% Bid Bond, and signed and sealed the Form of Tender and the Summary Sheet of the Schedule of Quantities and Prices. The low bidder, Aggressive Roadbuilders Ltd., has provided a Consent of Surety for a Performance Bond, a Labour & Material Bond, and has agreed to complete the work in 120 days as stipulated in the contract. Aggressive Roadbuilders Ltd., and their subcontractors, have previously completed several similar projects for the City and are currently constructing Phase 1 of the Fraser Highway upgrading, and we have found them to be qualified and acceptable.
