The Engineer's pre-tender estimate was \$1,730,000 including GST.

EVALUATION

All tenders were reviewed by our consultant. No legal or mathematical errors were found. All the tenders submitted the required 10% bid bond, and signed and sealed the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work in 110 days as stipulated in the contract. Winvan Paving Ltd.'s past performance on similar work with the City has been satisfactory.
