

Chuck Bailey Recreation Centre Expansion Survey Official Rules & Regulations

1) ENTRY PERIOD: The Contest begins at **6:00am on September 28, 2021** and ends at **11:59pm on October 20, 2021**.

2) ELIGIBILITY: You must be thirteen (13) years or older and a legal resident in the province of British Columbia (BC) to enter this Contest. If you are under nineteen (19) years of age you must receive the consent of your parent or guardian to claim a prize. City of Surrey employees and immediate family members of City of Surrey employees are not eligible to enter.

3) HOW TO ENTER: Between **6:00am on September 28, 2021** and **11:59pm on October 20, 2021** complete the **Chuck Bailey Recreation Centre Expansion Survey** and opt-in to the contest on the first page of the survey; and enter your first name and email address on the contest entry form at the end of the survey. You may enter a maximum of one (1) time: one (1) entry for fully completing the survey. This Contest is in no way sponsored, administered, or associated with Facebook, Inc., Twitter, Inc., or Instagram, Inc. By entering, entrants confirm that they are 13+ years of age, release Facebook, Twitter & Instagram of responsibility, and agree to Facebook, Instagram and Twitter's terms of use.

4) ENTRY GUIDELINES: The survey must be completed in full. Entries must be in English. Late or corrupt entries will not be accepted. Your entries must not be obscene or otherwise inappropriate, as determined by the City of Surrey in its sole discretion. Entries that are deemed inappropriate will not be accepted. You are responsible for obtaining, prior to submitting any entry, any releases and consents necessary to permit the exhibition and use of the entry in the manner described in these Official Rules without additional compensation.
