

## **Peer Mentorship Program Online Gallery Submissions Official Rules**

The City of Surrey is creating an Online Gallery that will be hosted on the City's website to raise awareness about the proper use and disposal of face masks. The City is inviting submissions from youth in Surrey for display in the Online Gallery.

### **1) SUBMISSION PERIOD**

Submissions to the Online Gallery begins at 9:00am on April 1, 2021 and ends at 11:59pm on April 30, 2021.

### **2) ELIGIBILITY**

You must be a under nineteen (19) years of age and a legal resident of the Province of British Columbia to contribute to the Online Gallery.

You must receive the consent of your parent or guardian to make a submission.

### **3) HOW TO SUBMIT**

Between April 1, 2021 and April 30, 2021 email an original design or photograph that raises awareness about the proper use and disposal of face masks to [youth@surrey.ca](mailto:youth@surrey.ca). Please include your name and age to confirm eligibility.

Submissions must be in either .JPG, .PNG or .GIF format, not exceeding 2MB (2048 KB) and must be static images. Animation and video will not be accepted.

Late or corrupt submissions will not be accepted.

Maximum number of submissions are limited to 3 designs per person.

### **4) SUBMISSION GUIDELINES**

All submitted designs, either hand-drawn or digitally designed, must be your own work. Your submission may not include any names or logos of other organizations or companies.

All submitted designs are to be inspired by information from Fraser Health about the proper use and disposal of face masks. See the [Fraser Health website](#) for details.

Your submission must not be obscene or otherwise inappropriate, as determined by the City of Surrey in its sole discretion.

### **5) INTELLECTUAL PROPERTY**

The City of Surrey may choose any submission in its sole discretion for use by the City at any time in its educational, community or marketing initiatives. The City of Surrey shall have the discretion in determining the extent and manner of use of submissions and is not obligated to use any submission.

The City of Surrey will have the right to use a submission in any merchandising, advertising, marketing, or promotion. Therefore, when you make your submission, you irrevocably grant to the City of Surrey the non-exclusive, perpetual, royalty-free, no-cost license and right to use your entry in any medium

including streaming media, film, television, print, interactive devices, mobile media, Internet and on-line systems, and digital billboards.

You understand that submissions that are posted on the City of Surrey website and related social media are available to be viewed by anyone with access to the Internet.

#### 6) TERMS AND CONDITIONS

By participating, you, and your parent or guardian, agree to abide by the Official Rules and the decisions of the City of Surrey, which shall be final in all respects.

The City of Surrey reserves the right to cancel or suspend the Online Gallery or this opportunity and cancel or refuse any submission.

#### 7) PRIVACY

The City of Surrey adheres to both federal and provincial privacy legislation. The City of Surrey is authorized to collect personal information under the section 26(c) of the Freedom of Information and Protection of Privacy Act. Personal information is collected for the purposes of the City of Surrey managing the Online Gallery and contacting individuals who have made submissions.
