

My concerns for this development are due to significant issues regarding privacy and increased traffic. The anticipated increase in traffic congestion, result in safety risks for pedestrians and could lead to longer commute times for residents.

The prospect of a large building being erected raises significant privacy concerns for me and my family. As our backyard is meant to be a sanctuary for relaxation and family time, the thought of having our privacy compromised by towering structures overlooking our property is deeply unsettling. It's not just about the physical proximity; it's also about the potential loss of intimacy that comes with feeling exposed to the constant presence of others.

I worry about the impact on our ability to enjoy our outdoor space freely, as well as the potential for increased noise and disruption from activities within the new building. Preserving our privacy is essential for our sense of security and well-being, and I hope that any development plans will take these concerns into careful consideration.

I understand that the developer has installed trees along the south perimeter in the buffer region however they will not be sufficient against the height of a 5 story building. One solution that I propose is the addition of tall (15-20ft) hedges along the south perimeter of the property. Strategically placed hedges can serve as an effective barrier, providing both visual screening and acoustic insulation for residents while enhancing the aesthetic appeal of the development.

However, I understand that the responsibility for installing and maintaining such hedges **should not burden** the property owner. Therefore, I kindly request that the developer consider including the <u>cost of installing and maintaining the hedges as part of the project budget and part of their own property</u>. This approach ensures that the privacy needs of surrounding residents are addressed without placing an unfair financial burden on individual homeowners.

Please thoroughly consider these concerns before reaching any decisions regarding project approval. I am absolutely opposed to the residential portion of this development.

- 1. Impact on Privacy: The proposed development appears to be close to existing residential properties. I am concerned about the potential loss of privacy due to the proximity of new structures.
