



SURREY PARKS DONATION BENCH PROGRAM

The City of Surrey's Park Donation Program invites residents to celebrate a special occasion or honour a legacy by making a donation to a City park bench. If you would like to make a donation, please submit an electronic copy of this form via email to partnersinparks@surrey.ca, or mail a hard copy to:

After an evaluation of your request, Parks staff will contact you to let you know if a donation is available in the park you've requested. All donations must directly benefit the people of Surrey and fall in line with the City's strategic park plan. The approved location of a bench installation depends on proposed future development within a park, the location of underground utilities, sensitive habitats, and other site restrictions. Some parks may already be at capacity and therefore a new bench may not be available.

New bench donations are not available at the following locations:

- Crescent Beach
- Blackie Spit Park
- Elgin Heritage Park
- Crescent Park
- Southmere Village Park
- Boundary Park
- Kwomais Point Park

As donations expire at these locations, any opportunities to dedicate existing benches will be advertised on the bench and will be granted on a first come first served basis: no waitlists will be maintained.

You may be asked to attend an on-site meeting at the park with the Park Partnerships Coordinator and technical staff. At this meeting, you will decide:

- What your donation will go towards: a new or existing bench
- Where your donation will be located
- What you'd like to have written on the plaque

Once your request is approved, you will be asked to provide your donation via cheque, cash or credit card. The Park Partnerships Coordinator will have your donation processed and the City of Surrey will issue you a tax receipt. Full payment is required upon final approval and the term begins once the bench is installed. When your installation is complete, you'll receive a thank-you letter from the Park Partnerships Coordinator. It is the donor's responsibility to keep current contact information on record with the City of Surrey.

Donors should be aware that they do not have any priority use of the donation. Donated benches and the space in which they are installed remain the property of the City of Surrey. While Parks Division staff does their best to maintain all park features in good condition and make repairs as needed, donated items will not be given priority treatment.

AVAILABLE OPTIONS AND COSTS

Option 1 - New Bench Donations:

All new bench donations are for a fixed 20 year term. Bench styles are pre-determined by City staff and are dependent on the future plans for the park. The prices listed below include the cost of the bench, an engraved plaque, installation, basic maintenance and repair of the bench for the 20 year term.

- Surrey Bench \$2500
- Cast (Frances Andrews) Bench \$3500

Option 2 - Dedications on Existing Benches:

Where a park has reached its capacity for new assets there is an option to donate to an existing bench. Dedication costs for existing benches will be based on a 20 year full bench life, as well as the specific type of bench available. Depending on the life span remaining, the donation cost will be pro-rated in 5 year increments.

- Surrey benches will be based on a cost of \$625/5 year increment
- Frances Andrews benches will be based on a cost of \$875/5 year increment

Age of Bench	Lifespan Remaining	Surrey Bench Cost	Frances Andrew Bench Cost
1 – 5 years old	15 – 19 years remaining	\$1875	\$2625
6 – 10 years old	10 – 14 years remaining	\$1250	\$1750
11 – 15 years old	5 – 9 years remaining	\$625	\$875
16 – 20 years old	1– 4 years remaining	New bench required at full cost.	

There may be additional requirements at certain park sites within the City. Please note that pricing may change over time.

RENEWALS

Once the 20 year term is complete the current donor will not have the option of renewal. The donation opportunity will be opened to a new donor.

LOCATIONS AND INSTALLATIONS

The approved location of a bench installation depends on proposed future development within a park, the location of underground utilities, sensitive habitats, and other site restrictions. Donations must contribute to the public enjoyment of parks and not interfere with the accessibility or use of the park by any member of the public. Donations must not interfere with park maintenance.

Full payment is required before a park bench is added. The term begins once the bench is installed. Installations occur twice per year in the spring and fall (weather permitting). Exact dates cannot be specified due to park construction and special events. Depending on the timing of your order, the installation will be scheduled for the next available installation date.

INCOME TAX INFORMATION

A tax receipt will be made out to the person paying in cash or with a credit card, unless a letter is provided at the time of payment indicating the individual donor names, addresses and amounts. If paying by cheque, each donor must submit a cheque to receive a tax receipt.

PARK DONATION BENCH POLICY

- The City shall have final approval of the bench type, location and plaque wording.
- The identity of donors becomes public record.
- Your donation is the property of the City of Surrey.
- Parks staff reserves the right to relocate or remove the donation whenever necessary. All reasonable effort will be made to notify the donor if their donation is affected.
- Placement of memorial wreaths, flowers or other items or any modifications to the donation will not be permitted.
- Donated assets will be maintained in good condition and repaired as needed by the City of Surrey for a 20 year term. Donated items will not be given priority treatment.
- Once the 20 year term is complete the current donor will not have the option of renewal. The donation opportunity will be opened to a new donor.
- City staff will review and adjust the costs annually.
