The following information is provided to answer questions raised by Proponents for the above named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Proponent or any sub-proponent not being familiar with this addendum. This Addendum No. 1 contains two (2) pages in total.

QUESTIONS AND ANSWERS:

Project Scope:

The purpose of the project is to identify the below defects to the City of Surrey sidewalk:

• Vertical Displacements 1"+ , Vertical Displacements Under 1".....

- Q1. What range of vertical displacements are to be identified and reported on Under 1" but greater than 1/4" or 1/8" etc...;?
- A1. Greater than a $\frac{1}{2}$ inch and up to under 1".

Letdowns;.....

- Q2. What specific information concerning Letdowns is to be identified and reported?
- A2. If they don't have a cross street connection(i.e. let down on one side of the road and not the other).

• Holes, Pavers;

Q3. On what specific information concerning pavers is to be identified and reported?

A3. Locations.

- Service Boxes, Missing Panels, Cracked Panels, Spalled Panels.
- Q4. Does Surrey currently have reporting software available and if so can you describe.
- A4. The software will be based of our ARC Map platform and will be a functional extension to City Works. The software will be tablet based and have simple fields to complete at the locations of defects.
- Q5. With regards to vegetation growth between sidewalk cracks, is this an issue Surrey would like identified and reported?
- A5. Not unless it's a significant it's a hindrance to pedestrian mobility. This includes vertical vegetation growing horizontally into the sidewalk path (i.e. greater than 25 percent of the sidewalk is blocked).
- Q6. Is the primary focus of the inspections hazard identification and reporting or is it an exhaustive overall assessment.
- A6. Hazard identification.
