INFORMATION FOR PROPONENTS

Proponents are advised that Addendum No. 3 to 1220-030-2022-006 is hereby issued by the City. This addendum shall form part of the contract documents and is to be read, interpreted and coordinated with all other parts. The following information is provided to answer questions raised by Proponents for the above-named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Proponents or any sub-contractor not being familiar with this addendum. This Addendum No. 3 contains two (2) pages.

QUESTIONS AND ANSWERS:

- Q1. What kinds of the City's street infrastructure do you want to analyze? Only pavement or other assets (now or potentially)?
- A1. The City would like a solution that can or has the potential to identify multiple service in the road allowance. Examples may include potholes, litter, dumping, damaged signs, tree branches etc. The City is encouraging the Proponents to prepare a Proposal that demonstrates the innovation to meet these needs or additional solutions.

- Q2. For what purpose do you need the integration with any and existing City mobile application systems? What existing City mobile application systems do you have? What are their purposes?
- A2. Integration with the City's current mobile equipment is not a requirement but the City would like to see a solution that can integrate with the City's CityWorks system to create service requests.
- Q3. In what form do you need the final deliverable? E.g. a PIC index? Or a map layer of individual potholes? What are the types of road defects you want to be recognized?
- A3. The City would like to see a pdf with attributes such as location/address, deficiency, picture and map with the location. For the defects please see Q1 response.
- Q4. What is the total mileage of the City roads?
- A4. The City has over 4000 lane kilometers.
- Q5. How frequent do you require the pavement quality inspection data to be updated?
- A5. This is not a critical piece of data.
- Q6. Do you have a fleet of vehicles where the road surface scanning mobile app could be installed under the windshield?
- A6. Yes.
- Q7. Can Proponents apply for the RFP if they are non-residents of Canada?
- A7. Proponents may submit a Proposal even if they are non-residents of Canada.

All Addenda will become part of the Contract Documents.
