## **INFORMATION FOR APPLICANTS**

This Addendum is issued to provide additional information to the RFA-SOA for the above named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Applicant not being familiar with this Addendum. This Addendum No. 1 contains two (2) pages in total.

## **QUESTIONS AND ANSWERS:**

- Q1: In Table 7: Response Times it states the following: Emergency Service Response Time During Regular and Outside of Regular hours: Within 1 Hour. Please clarify if the response time for personnel is to be onsite within 1 hour, or is the response time to have a crew mobilized within 1 hour?
- A1: Onsite within one (1) hour.
- Q2: Below Table 2 states the following: "Labour Rates states that the labour rates are all inclusive, without limitation, wages, benefits, vehicle, fuel, tools, mobilization and demobilization, over and profit". Please provide a scenario for proponents to identify the anticipated costs, in certain situations responses may require certain specialized equipment which could have a significant effect on costs +/-.
- A2: Applicants can use Table 3: Rates for Hazardous Waste Collection and Disposal for specialized equipment and other rates that don't fit into Tables 1 and 2.

- Q3: In Table 3 Haz-waste Collection and Disposal is seeking rates for Hazardous Waste Collection and Disposal:
  - (a) Are there common waste streams of which City of Surrey generates of which the proponents can provide pricing against?
  - (b) Additionally, to the common waste streams, can you provide estimated quantities of said waste streams?
- A3: (a) See Schedule A section 2.4 for a non-inclusive list.
  - (b) Quantities vary by amount found dumped. Each location will differ in the amount. The most common item found dumped is drywall.
- Q4: Are collection rates specific to a City of Surrey's works yard located at 6651 148th St. Surrey? If the answer is no, can you please provide a generating location of said waste for proponents to price appropriately?
- A4: Hazardous waste collection may be at various locations within the City.

The Contractor must warrant that the facilities they use to destroy and/or dispose and/or recycle and/or treat each hazardous waste type comply with all applicable laws and that the Contractor and the facility have all permits and licenses required to carry out the proposed tasks. Such proof must be made available to the City.

The Contractor must provide adequate proof that the facility disposing the City's hazardous waste has authorization and approval for such disposal.

- Q5: Does the collection of waste require processing, packaging, bulking and or providing containers for the purposes of Transport and Disposal?
- A5: Contractor to determine. Contractor must comply with all applicable laws. The Services requested by the City may include the list of hazardous wastes that require disposal at an approved facility. The Contractor is expected to attend the site, package and collect these wastes prior to transporting the materials off site for disposal.
- Q6: Can an additional schedule of rates be provided in an appendix or are proponents required to only utilize the line items available in Table 1 through 3?
- A6: Applicants should complete Tables 1 to 3 so the City can compare Applications. Applicants may attach to their Application additional rates.
- Q7: Can proponents insert additional comments below each table should they need to clarify what may be included within specified rates?
- A7: Yes.
