INFORMATION FOR CONTRACTORS

This Addendum is issued to provide additional information and clarifications to the RFA-SOA for the above-named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Proponent not being familiar with this addendum. This Addendum No. 1 contains two (2) pages.

QUESTIONS AND ANSWERS:

- Q1. There is no recommended model for the TYPE 3 camera. Can you please confirm if AXIS Q6128-E is accepted by the board?
- A1. **The Axis Q6128-E will be accepted for the Type 3 camera.**
- Q2. We did not find any quantity for the requested camera types. Would you please give us the estimated quantity?
- A2. **Goods under this RFA-SOA will be ordered by the City solely on an “as and when required” basis. Please see Page 3 of the RFA-SOA.**
- Q3. Is it the intent of the board to use TYPE 5 (AXIS Q6000-E) in combination with TYPE 1/2/3 (Axis Q61-E series)? Or are they supposed to use TYPE 5 as solo installation?
- A3. **The intent is to use the Axis Q6000-E in combination with Type 1/2/3 cameras.**
- Q4. In regard to previous question, please specify how many of TYPE 5 cameras are estimated to be used solo and how many are estimated to be used in combination with TYPE 1/2/3?
- A4. **All Type 5 cameras are intended to be used in combination with Type 1/2/3 cameras.**
- Q5. What is the preferred mounting bracket for TYPE 1/2/3/5 by the board? Is the POLE MOUNT BRACKET required?
- A5. **The preferred mount for Type 1/2/3/5 cameras is the Axis T91L61 Wall-and-Pole Mount.**

- Q6. What is the preferred mounting bracket for TYPE 4 (fisheye camera)? Is the WALL MOUNT with PENDANT KIT required?**
- A6. The preferred mount for the Type 4 camera is the Axis T91B67 Pole Mount. The outdoor pendant kit is required.**
- Q7. It is noted that the board is requesting Compatible PoE injector for all camera types. Is the board interested in mounting bracket with integrated PoE Injector? Recommended model is AXIS T91H61 Wall Mount**
- A7. The City is not currently seeking a mounting bracket with integrated PoE injector at this time.**
- Q8. Is the bidder responsible for configuration of cameras?**
- A8. The City will be responsible for the configuration of the cameras.**
