### INFORMATION FOR PROPONENTS

Proponents are advised that Addendum No. 1 to 1220-041-2020-003 is hereby issued by the City. This addendum shall form part of the contract documents and is to be read, interpreted and coordinated with all other parts. The following information is provided to answer questions raised by Proponents, for the above-named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Proponents, or any sub-contractor not being familiar with this addendum. This Addendum No. 1 contains two (2) pages.

### QUESTIONS AND ANSWERS:

- Q1.** Schedule B-1, Index # 5 (q) "Police Silent Mode"; can you clarify what you require for Police Silent Mode? This is not a Ford factory option so must be installed by the upfitter. Also, can you confirm this is a Mandatory item?
- A1.** Yes this is mandatory, when activated courtesy lamps, chimes and daytime running lamps are disabled.
- Q2.** Schedule B-1, Index # 5 (s) "Daytime Running Light cutout"; This is not a Ford factory option so must be configured by the upfitter. Is the customer needing the DRLs permanently disabled or switchable on/off by the driver?
- A2.** Switchable, from CenCom.
- Q3.** Schedule B-1, Index # 5 (II) "Traffic Advisor"; confirm you are asking for an 8-head traffic advisor that has one red module and one blue module, with 6 x amber modules (to function as traffic direction lights) in the middle?
- A3.** Correct, controlled by CenCom.

- Q4.** Schedule B-1, Index # 6 (a) "CF31 docking plate"; can you please confirm that Surrey needs a CF-31 dock since the CF-31 computers have been discontinued by Panasonic? Or do they require a CF-33 dock?
- A4.** We are currently using CF-31 so we can utilise our existing computers. Suggest a cost is provided for both options.
- Q5.** Siren Speakers. There is some conflict between the following sections of the bid Schedule B-1;
- Index # 6 (k) "push bumper"; this item indicates an "additional siren speaker".  
Section 5 (o) indicates "100 watt siren speaker".  
Index # 6 (g) mentions a siren control system "that includes one [siren] speaker"
- A5.** CenCom controller.
- Q6.** If you could please provide some clarification as to exactly how many 100-watt siren speakers you require on the vehicle, that would be appreciated.
- A6.** 2 - 100 watt sirens speakers mounted on the push bumper.
- Q7.** The bid requests a number of "Additional Optional Items" found on page 38 of the main RFQ document. Are bidders supposed to be specifying individual prices for each of these items? If so, where would you like those prices indicated, as there doesn't appear to be a pricing table for those items included in the bid response document.
- A7.** Please price separately, however these items will likely be required in the build of these new vehicles.
- Q8.** Section 2 Exterior. Index # d. Wheels and Tires  
Wheels, tires 5 (including spare) - mounted on steel wheels - all tires to be balanced, spare to be full size and of same type above. Including tire pressure monitoring, preference is for all weather tires with snowflake M&S to meet Police vehicle specifications "V" Rated.
- A8.** Winter Tires (snow flake) in lieu of All-Season Standard Tires.
- Q9.** Is the Surry Police Service only looking for V rated snow tires installed on the vehicle at delivery. Or are the snow tires in addition to the all-weather tires?
- A9.** V rated snow tires at the time of delivery, not an addition to the all weather tires.
