Questions and Answers:

The Surrey Police Service has received a number of questions regarding the clarity of items required as per the following:

1. B. Ear Wire Kit (Are you looking for 3L or 2L wires)
2. C. Duty Bags – All these bags have the same capacity and same pouches. Can we offer another brand than 5.11 ...
3. E. Notebook Cover – Are you looking for leather or nylon?
4. F. Safety glasses – Do you have a brand you like?
5. H. Expandable Baton – Are you open to trying the NEX baton? ...
6. I. Baton holder – If you are open the NEX, we also have a holder available.
7. J. Duty Belt – Are you looking for an inner and outer belt combination
8. O. Glove Pouch – Is this for latex gloves or leather gloves?
9. P. OC Spray holder – Is this for MK3 or MK4
10. S. Rescue Tool – Leatherman – Which model?

Answer:

1. **Contractor Recommendations.** If a make/model has not been specified, SPS will consider Contractor recommendations for those Goods which conform to the specifications, critical dates and all other identified requirements of SPS, which may provide cost, performance, maintenance or other advantages to SPS and which meet or exceed standards and expectations required for use in policing and law enforcement.
2. **If Substitutions Permitted.** The make/model specified is the preferred make/model. However, SPS may consider alternatives the Contractor considers superior, or which offer cost, performance, maintenance or other advantages to SPS, provided such alternatives conform to the specifications, critical dates and all other identified requirements of SPS.
3. **If No Substitutions Permitted.** Unless the Good has been discontinued or is not readily available at the commencement of the contract term, SPS will not consider substitutions

to the make/model. If technology and models change during the contract term, SPS may accept substitutions for subsequent orders at the relevant time through Change Order.
