#### INFORMATION FOR CONTRACTORS

This Addendum is issued to provide additional information to the RFQ for the above-named project, to the extent referenced and shall become thereof. No consideration will be allowed for extras due to the Contractor not being familiar with this Addendum. This Addendum No. 2 contains two (2) pages in total.

#### QUESTIONS AND ANSWERS:

**Q.1.** The 14613- 64 Avenue location notes a 53' semi-trailer is required for mattress collection. Is the Contractor responsible for providing this trailer?

**A.1.** Yes, the contractor will be responsible for providing the trailer (and all roll-off bins required as part of this contract).

**Q.2.** Can the City please confirm what is included within "yard waste/organics"? Does this include food waste?

**A.2.** This refers organic yard/garden waste, including plant debris, grass clippings, tree clippings, leaves and other trimmings, tree and hedge branches/prunings, plants, flowers and other organic yard/garden waste. It is unlikely food waste will be included in with the yard waste.

**Q.3.** Who is responsible for removing the CFCs from the white good items?

**A.3.** It will be the contractor's responsibility to find a recycling facility that accepts metal/ white goods the still contain CFC's and remove as required.

**Q.4.** Can the City provide the number of hauls that were required in the past 12 months by material type and location?

**A.4.** Please refer to 'Schedule A-1 Service Locations, Container Requirements, and Service Frequency' for approximate collection frequencies from 2020.

**Q.5.** Section 12.1 states, "All operators shall wear the proper personal protective equipment to perform organic waste cart washing Services." Could the City clarify what is expected of the Contractor with regards to this specific service?

**A.5.** Refer to Schedule A – Specifications of Goods and Scope of Services:

Delete Section 12 Operator Safety Equipment and Apparel, as issued for quotation in its entirety and substitute with the following:

**"12. OPERATOR SAFETY EQUIPMENT AND APPAREL**

12.1 All operators shall wear the proper personal protective equipment to perform the Services which shall include but are not limited to CSA approved footwear, eye, and hearing protection in accordance with the Occupational Health and Safety Act, WCB of British Columbia and in accordance with the equipment manufacturer's operating instructions while performing Services."

**Q.6.** Will any of the containers require lids?

**A.6.** No, not at this time. If, in the future, it is determined a lid is required for a particular roll-off bin, the Contractor will be given adequate notice.

**Q.7.** Does the City have a current list of approved facilities for Disposal & Processing?

**A.7.** Refer to Schedule A – Specifications of Goods and Scope of Services, Section 3.1.
