DELETE in its entirety and REPLACE with the following:

### 2. REFER TO SCHEDULE B – APPENDIX 2 SUPPLEMENTARY SPECIFICATIONS PROJECT

Section 2.0 Products

DELETE in its entirety 2.1.2 Condenser and REPLACE with the following:

"Capacity of the new condenser: 60.0 Tons of Ammonia Refrigeration plus, motor load from the compressor and separate load from the glycol cooling loop for compressor glycol jacket."

# 3. REFER TO SCHEDULE B - APPENDIX 2 SUPPLEMENTARY SPECIFICATIONS PROJECT

Section 1.0 General Requirements, under 1.2 Scope of Work:

(a) DELETE in its entirety section 1.2.31 and REPLACE with the following:

"Provide relief valve calculations demonstrating size of the new relief line meets the code requirements as required by the TSB directive"

# 4. **NEW INFORMATION**

The refrigeration contractor is to carry a prime cost sum of \$12,000 for the engineering, design, and construction of a new concrete base the condenser. The prime cost sum is to include repairs and repainting to existing fencing. The City of Surrey will carry the cost of the building permit.
