INFORMATION FOR CONTRACTORS

Contractors are advised that Addendum No. 1 to 1220-040-2022-044 is hereby issued by the City. This addendum shall form part of the contract documents and is to be read, interpreted and coordinated with all other parts. The following information is provided to answer questions raised by Contractors for the above-named project, to the extent referenced and shall become a part thereof. No consideration will be allowed for extras due to the Contractors or any sub-contractor not being familiar with this addendum. This Addendum No. 1 contains two (2) pages.

QUESTIONS AND ANSWERS:

- Q1. Is the City tendering this project to a GC? We are typically subbed out as we only supply scaffolding services
- A1. The City is requesting Submissions which encompass the full Scope of Work. Successful Contractor will be designated as Prime Contractor for the entire Scope of Work.
- Q2. What is to be done with the concrete suspended slap Repair denoted on Drawing No. S-2287-1.2.
- A2. Please disregard this notation as related to this RFQ. Suspended slab repairs have been previously completed.
- Q3. On the scaffold section Detail 7, is existing plywood deck to be removed and replaced? Or are we just sheeting over top of existing plywood with new 5/8" Treated Ply?
- A3. Detail 7 Drawing No. S-2287-3.2 indicates new 5/8" treated plywood to be installed overtop the existing plywood. However, the City would also like to request Optional Pricing be included for the full removal of existing top layer of plywood decking, prior to installation of <u>new 3/4" layer</u> of pressure treated plywood.

- Q.4 On drawing # S-2287-01.1; is the unused bleacher to be removed to another area for storage, or removed and disposed of?
- A4. Unused bleacher section is to be removed and disposed of offsite.
- Q5. On drawing # S-2287-01.1 & S-2287-2.1 in red it says Bleacher #1 Individual Boards remove and replace and replace, seat and floorboards. Are those the only boards we account to replace at this time?
- A5. The Tables for "Individual Seat and Floorboard Removal and/or Replacement" on Drawings 1.1 and 2.1 refer to boards over and above any other areas bubbled and indicated on the Drawings as needing removal and/or replacement. The boards referred to in the Tables are randomly located and have been physically marked and identified onsite with marking paint.
