Darren Henderson was in attendance to discuss the denial of a permit to construct a skateboard ramp on private acreage.

Mr. Henderson provided the following comments:

- That he and his partner have built a skateboard ramp for personal use on his property.
- That the City of Surrey issued a Stop Work order on the ramp because he had not applied for a building permit.
- That he contacted his neighbours and offered information on the skateboard ramp.
- That a letter of support had been received from a neighbour, K. Krawchuk.
- That the other neighbours have not expressed any opposition to the skateboard ramp.
- That he is an athlete, considers skateboarding a sport, and intends to compete.
- That he showed a drawing indicating the site of the ramp on his property.
- That there is a buffer area between his property and his neighbours' properties.
- That there are inadequate skateboarding training facilities in the area.
- That he has obtained sufficient insurance coverage and would provide waivers to others wishing to use the ramp.
- That the ramp is chained up when not in use.
- That a building inspector indicated there were no structural problems with the ramp.

Councillor Bose entered the meeting at 5:11 p.m.

Council noted that staff will forward a report to Council based on the information provided as soon as possible. Council also suggested that no action be taken until the report is submitted to Council.
