Tamara van Tunen was in attendance regarding the West Whalley Ring Road extension to Holland Park.

Eileen Hyska was also in attendance and provided the following comments:

- That she is a resident of Ted Kuhn towers located at 13350 and 13352 Old Yale Road.
- That many senior citizens reside at the Ted Kuhn towers and many use wheelchairs, scooters and seeing-eye dogs for mobility purposes.
- That the location of the proposed road would be detrimental to the quality of life for senior citizens and would present safety problems at crosswalks, health issues due to exhaust from cars, and increased noise levels.
- That an invitation has been extended to Mayor and Council to view the location.

Tamara van Tunen then provided the following comments:

- That the proposed application would bring an estimated 12,000 cars into the neighbourhood during the first year after construction and an estimated 2% increase in each year following, not including traffic to the shopping mall and office tower.
- That the safety of 2,200 children attending three schools in the area would be affected.

- That the safety of senior citizens residing in the Ted Kuhn towers would be affected when using the crosswalk and by the increased traffic noise.
- That removal of the trees at Holland Park would take away a natural sound barrier.
- That the elders of the community have contributed to society and respect should be shown for their need for a peaceful and healthy living environment.
- That the GVRD advises that trees provide oxygen, storage for carbon monoxide, and water as well as homes for plants and animals.
- That Holland Park lands were reserved for park purposes and Council is requested to keep it as it is.
