Ken Shymanski, President & CEO, Tracey Lee Lorenson, Vice President & Corporate Counsel, Beatrix Henning, Vice President & CFO, Jody Robertson, Director of Corporate Communications, Emergency Communication for Southwest British Columbia Incorporated (E-Comm 9-1-1) were in attendance to provide an update on E-Comm, their services, and emergency communications issues facing the region.

Ken Shymanski provided the following comments:

- E-Comm is the main regional 9-1-1 call centre for the GVRD, Sunshine Coast, and Whistler.
- E-Comm owns and operates a wide-area radio system for the GVRD and provides emergency dispatch services for a number of agencies.
- There are a number of police agencies using the wide-area radio system, and it was noted that the strength of the radio system allows all police officers to travel and maintain contact with all police offices and ambulance services in the GVRD.
- Surrey's fire, ambulance and police services utilize this radio system which allows emergency responders to communicate amongst each other without having to use different radio devices.
- E-Comm's radio statistics indicate that no more than 3 calls out of 100 are queued for more than 4 seconds during peak times.

- E-Comm's actual services is 0.02% greater than the engineering limits and runs at 99.99% of maximum capability.
- Customer surveys were conducted in 2002 and 2004 and users were asked throughout the GVRD on how they found E-Comm's services it was noted that 70% of customers surveyed were satisfied. E-Comm's target is 80%.
- E-Comm also provides emergency dispatch operations for the RCMP in Ridge Meadows, UBC and the Vancouver Police Department.
- E-Comm handles 9-1-1 calls and transfer them to the appropriate agency to handle.
- The customer satisfaction survey of dispatch services shows improvement in the dispatch services offered.
- E-Comm's members agreement identifies those who own shares and share infrastructure costs, much like a cooperative.
- Surrey has two Class "A" shares: one for police and one for fire.
- E-Comm's financial model is one of break-even and the operating and revenue budgets are \$45 million.
- E-Comm's Board of Director comprises 17 members, 3 independent Directors and the Board Chair is an independent director.
- Chief Len Garis represents the City of Surrey.
- There will be an Annual General Meeting held May 5, 2005 and re-election for directors.
- Funding sources are through collection from the GVRD for 9-1-1 services, levy on Class "A" radio shareholders, based on type of service, geography, population, and how often the service is used.
- E-Comm is treated as a municipality because shareholders are all municipalities, borrowing from the Municipal Finance Authority.
- E-Comm started without equity, borrowing every penny to construct facilities. Levies cover debt repayment, principal and operating costs.
- Critical issues include cellular phones it was noted that there is a mandate from the United States for mobility companies to provide precise information and location information relative to cellular phone use; and internet phone use.

2. Jim King, Chair, Capital Campaign Friends of the Surrey Museum & Archives Society File: 0250-20; 0550-20-10

Jim King, Chair, Capital Campaign, Friends of the Surrey Museum & Archives Society was in attendance to provide an update on the funds the Society has raised to date for the new museum.

Jim King provided the following comments with respect to donations to the Capital Campaign:

- Individuals have donated \$34,000.
- Corporate donations from such organizations as Coast Capital Savings, Black Press, Shepherd Brothers, and Westminster Savings have contributed \$108,500.

- Other charitable organizations in the community such as the Surrey Historical Society, North Surrey Lions Club, Cloverdale Lions Club, the Rotarians, Ukrainian Self Reliance, Canadian Stream Preservation Society, Knights of Columbus, Surrey Fire Fighters, the Vancouver Foundation, Surrey Foundation, collectively have donated \$124,600.
- The Society has submitted an application for a federal grant for \$84,000.
- In kind donations from the Surrey Leader, Peace Arch News, and Cloverdale Rotarians have been provided to cover the cost of a clock to be built on site.
- Total donations total \$501,000.
- The Society asks Council to support the ongoing need for display cases, table chairs, textiles, and technology.
- The Society feels confident that it will bring more money to the table.

- Obtain Council's approval to bring forward the necessary amendments to the OCP By-law and Zoning By-law to formalize the amenity contribution requirements for development in this NCP Extension area.

- 2. Approve the final and complete East Clayton Neighbourhood Concept Plan ("NCP") Extension West of 188 Street, as contained in Appendix "A" to this report, as a means of managing development and providing services, amenities and facilities in support of the development of this neighbourhood;
- 3. Instruct the City Clerk to introduce a by-law to amend the Surrey Official Community Plan By-law, 1996, No. 12900 (the "OCP By-law"), as documented in Appendix "D", to add the East Clayton NCP Extension West of 188 Street to Figure 27 entitled "Map Showing Recently Approved Secondary Plans";
- 4. Instruct the City Clerk to introduce a by-law to amend Surrey Zoning By-law, 1993, No. 12000 (the "Zoning By-law"), as documented in Appendix "E", to require amenity contributions from development in the East Clayton NCP Extension West of 188 Street area, based upon the density bonus concept; and
- 5. Authorize staff to amend the Clayton Local Area Plan (1999) on the basis of the approved final and complete East Clayton NCP Extension West of 188 Street.
