In attendance before Council, to provide information relative to Arts Council initiatives and commentary on the proposed South Surrey arts facility.

The following comments were made:

- The Semiahmoo Arts Council provided an overview of their initiatives and programming.
- The delegation explained they are an 'umbrella organization' representing a full arts portfolio and are looking to build a separate arts facility in the South Surrey Area, share their expertise and be involved in a collaborative capacity.
- The Semiahmoo Arts Council stated their wish to build and strengthen their relationship with the City of Surrey in development of a South Surrey Arts Centre.

Staff reported that the Parks, Recreation and Culture Strategic Plan, identified a need for another arts building within the South Surrey area. The Build Surrey Plan responded to that need and a review is scheduled to take place in 2011. A consultant group has been engaged to meet with various arts groups within the South Surrey area to identify needs. The new centre is currently proposed as an addition to the existing South Surrey Recreational facility.

Council requested the Semiahmoo Arts Council to provide an up-to-date organizational chart clearly illustrating the various organizations the Semiahmoo Arts, Community Arts Council of White Rock represents.
