In attendance before Council to ask that Council consider amending "Surrey Noise Control By-law, 1982, No. 7044" to reduce the permitted hours of construction in residential areas within the City by amending the hour of 10:00 p.m., which is currently permitted, to a more reasonable hour.

The following comments were made:

• The delegation lives next door to a large townhouse construction project which is now in its third year. The existing noise by-law in the City of Surrey allows for construction to continue until 10:00 p.m. The delegation noted that construction in the City of Vancouver must cease by 8:00 p.m. and would like to see the same for the City of Surrey.

Council asked staff to report back to Council on this matter.

2. Elizabeth Model, Chair, Surrey Marathon Society, and Janilaine Tsui, SFU Student

In attendance before Council to provide information on a new 10 km run being planned by the Surrey Marathon Society for September 6, 2014.

The following comments were made:

• Beats on the Street is a new 10k run and 5k walk being organized for September 6, 2014.

- The four components of this event are:
 - Running
 This is a 10k run and 5k walk, focusing not only on fitness but on having fun as well.
 - O <u>Music</u>
 There will be different genres of music along the route, as well as different cultural and ethnic types of music.
 - Fun

 There will be a concert and party at the conclusion of the event.
 - Community
 It is a family friendly event for runners and walkers of all ages and abilities.
- This year's event will be held on Saturday. September 6, 2014 at 4:00 p.m, and will put Surrey on the map in terms of economic development, targeting people who are training for longer distance marathons. Every large city has a signature run and this will build a signature run in downtown Surrey.
- The official charity of the run is the Surrey Firefighters, who have been asked by event organizers to funnel some of the funds into Innovation Boulevard.
- The delegation is asking the City of Surrey for \$20,000 for marketing purposes; they have other sponsors lined up as well.

In response to a question from Council, the delegation noted that there will be a recovery zone for the runners and walkers where they can obtain refreshments. Event organizers will be looking to partner with the City to have food carts available for those in attendance who are not participating in the run.

The delegation distributed a map of the planned route for the run, keeping it west of King George Boulevard and scaled back to 10k from last year's longer run, so as not to impede traffic around emergency centers such as Surrey Memorial Hospital.
