A. DELEGATIONS

In attendance before Council to provide a presentation regarding airport initiatives and activities, providing the following comments:

- Vancouver Airport Authority receives no government funding and represents a private non-shareholder base corporation;
- YVR pays rent to the Federal Government while improving the Airport and its services;
- In 2015, YVR welcomed 20.3 million passengers, representing a 5% increase from the previous year;
- YVR is Canada's second busiest airport with a peak day seeing 75,000 travellers;
- By 2020, YVR's goal is to reach 25 million passengers which will result in more jobs, GDP growth and many other spin-off effects in tourism;
- In 2015 a new strategic plan was developed to position YVR in the community for growth and achieve the following objectives:
 - Creating a world-class connecting hub;
 - o Delivering remarkable customer experiences;
 - o Building a leader in sustainability; and
 - Building on the exceptional foundation.
- YVR is working closely with all the airlines, and released a new rates and charges scheme resulting in a 15% decrease in fees for airlines;

- A number of new airline services have been added and enhanced at YVR;
- In creating a connecting hub, YVR has introduced initiatives aimed at improving travel;
- YVR has been awarded as the best airport in North America 7 years in a row by the Skytrax World Airport Awards;
- There are many projects in progress aimed to improve the customer experience, such as high speed baggage program, a new security screening system processing passengers faster;
- In terms of sustainability, YVR's 2014 Environmental Management Plan there are four over-arching targets for 2020:
 - o Reducing greenhouses gases by 33%,
 - o Reducing waste by 50%,
 - o Reducing potable water consumption by 30%, and,
 - Improving ecosystem health.
- In measuring the 2015 results against the four over-arching targets, the results are promising, as 46% of waste has been successfully diverted;
- Being a leader in sustainability is also about how the airport is governed, and YVR's current non-profit model assures that YVR is accountable to its community members, giving precedence to local government matters; and,
- The Master Plan "YVR 2037" is in the second consultation phase focussing on six specific areas:
 - Land use;
 - o Airside and airspace operations;
 - o Ground access;
 - o Environment;
 - o Amenities; and
 - o Terminal.

Council expressed appreciation for the presentation and suggested to the delegation that the consultation phase should reach out to those stakeholders who have in the past expressed noise-management and flight path related concerns.
