A. DELEGATIONS

1. Stephen Dooley, Co-Chair Surrey Poverty Reduction Coalition File: 5080-01; 0550-20-10

The delegation provided a PowerPoint presentation regarding the implementation of the Surrey Poverty Reduction Plan and highlighted the following information:

- The Surrey Poverty Reduction Coalition was formed in 2012 to guide the implementation of the Surrey Poverty Reduction Plan. The Coalition consists of 20 community partners.
- Recommendations in the area of transportation, housing, income and support have been created.
- There are approximately 20, 000 youth living in poverty in Surrey, which is comparable to the provincial average child poverty rate.
- The Coalition has hosted three community forums aimed at bringing the community together for action and inspiration.
- The Coalition projects' include Community Leaders Igniting Change (CLIC) and Connecting Community to Surrey Youth Leaving Care.
- The Coalition has advocated for the Refugee Transportation Loan Program, and a petition in support of the program was presented to Parliament in 2016.
 - \$25,000 from the Council Initiative Funds is being requested to support the work of the Coalition, as well as continued future support from the Annual Social Planning budget.

Discussion ensued, and Council made the following comments:

- Good example of what other levels can do is clear in the direction of various organizations and other levels of government and community what they can do
- Use coalition members' time to work on the plan, not for filling out grant applications
- Works with social planning, affordable housing plan (new) and homelessness plan
- In response to questions from Council, staff advised that the federal government has advised that the transportation repayment program is currently under review. Unclear as to whether there will be changes made to the program.
