A. CORPORATE REPORTS

1. The Corporate Reports, under date of May 9, 2011, were considered and dealt with as follows:

Guildford Indoor Pool - Project Scale and Schedule

The General Manager, Parks, Recreation and Culture and the General Manager, Finance and Technology submitted a report to provide information about the design of a new indoor pool at the Guildford Recreation Centre, which is an element of the Build Surrey Program and that was approved as part of the 2011 – 2015 Five-Year Financial Plan. This report recommends adjustments to the scale and timing of the project.

The General Manager, Parks, Recreation and Culture and the General Manager, Finance and Technology were recommending approval of the recommendations outlined in their report.

Council requested detail on how a larger the pool redesign is possible. Staff clarified that the design runs along the area east and north of the existing facility. Previously staff thought there were environmental restrictions on the site, it was determined through extra investigation the entire land is available for use.

In response to Council inquiry, staff confirmed that the operating budgets were based on past facilities and the project is part of the 'Build Surrey' project. In response to Council query relative to available funding for cultural space, staff noted the proposed expansion is part of the financial plan and the Art's Space could be reviewed for the 2012 - 2016 plans for Surrey's cultural needs.

Staff shared that usage of the outdoor pools and their condition will be assessed. At this point staff is continuing to operate the outdoor pools and noted the results of the overall cultural plan will be posted for review in coming months.

that Council:

- 1. Approve an amendment to the 2011 2015 Five Year Financial Plan that will act to bring forward to 2011 sufficient funding to allow the design of the Guildford Indoor Pool to be commenced in 2011 with the design including a pool length of 52.5 metres; and
- 2. Instruct staff as part of the 2012-2016 Five Year Financial Plan to allocate appropriate funding to allow the construction of the proposed Guildford Indoor Pool with a 52.5m pool length to proceed in 2012 upon completion of the design and tendering process for the project.
