There was correspondence on table from D. and A. Moan expressing opposition to the proposed rezoning application.

The Mayor noted that L. Gill and B. Reid had expressed support for the proposed rezoning application and not wishing to speak.

<u>Kathy Poirier</u>, 14605 Winter Crescent, was in attendance and commented that her parents had questions regarding landfill relative to the dyke, flooding, payment of flood damages, and retaining walls. She noted that she had concerns regarding protection of wildlife corridors along the river.

<u>Douglas and Arline Moan, 3545 – 146A Street</u>, were in attendance and commented that they had concerns regarding development of homes in a flood prone area. Arline Moan noted they had corresponded with staff and only just received a response. Douglas Moan raised concerns regarding landfill, sanitation, septic fields, pressurized sewer lines, increased traffic, protection of wildlife, capacity of elementary schools, and tree preservation.

There was correspondence on table from S. and C. Evans expressing concerns regarding increased traffic on 137A Street, property value devaluation, construction noise and traffic, and loss of privacy.

<u>Stan Evans</u>, 9690 – 137A <u>Street</u>, was in attendance and commented that he had concerns regarding building height, increased traffic, parking, loss of privacy, public safety, and proximity of proposed development.

<u>Curt Fisher</u>, 3372 – 155 <u>Street</u>, was in attendance and commented that the proposal is for a care facility. He noted that the proposed development would have four storeys plus a partial fifth storey. He continued that the developer had already purchased several lots in the area and has plans to purchase further lots at a future date.

<u>Cheryl Evans</u>, 9690 - 137A <u>Street</u>, was in attendance and commented that they had not been approached by a real estate agent regarding the purchase of their home.

There was correspondence on table from T. Karoway and K. and J. Boles expressing concerns regarding increased traffic, crime, and noise, street lighting, safety of schoolchildren, driveway, parking, proximity of liquor store to elementary school, lack of sidewalks, lack of pedestrian crosswalk, and tree preservation. There was also correspondence on table from T. Ong expressing opposition to the proposed rezoning application.

<u>Greg Wool, 10179 – 159A Street</u>, was in attendance and commented that he had concerns regarding the proposed liquor store and proximity of elementary school, and increase in traffic on 156 Street.

<u>Tony Jones</u>, <u>128 – 10183 – 156 Street</u>, was in attendance and commented that he had concerns regarding the proposed liquor store and proximity of elementary school.

<u>Tammy Karoway, 10226 - 157 Street</u>, was in attendance and commented that she was opposed to the proposed rezoning application. She continued that she had concerns regarding safety of children and the proximity of the proposed liquor store.

She continued that the City by-law states that a pub cannot be located within 400 meters of elementary schools. She advised she also had concerns regarding increased traffic, proposed underpass to the Fraser Heights area, and traffic flow along 104th Avenue. She noted that the proposed development at 176 Street and 96 Avenue would be a more suitable site for such a use.

<u>Kelli O'Malley, 10234 – 156A Street</u>, was in attendance and commented that the proposal would be detrimental to the community. She raised concerns regarding the proximity of a liquor store to an elementary school and increased traffic. She expressed concern regarding truck traffic speeding through intersections.

<u>Jenifer McGuinness</u>, 15562 – 104A Avenue, was in attendance and commented that she preferred multi-residential development rather than commercial. She continued that she had concerns regarding increased traffic, safety of school children, and truck traffic. She requested Council consider a pedestrian overpass on the west side of 104 Avenue between 156 and 157 Streets.

<u>Ken Boles, 10467 – 156 Street</u>, was in attendance and commented that he was opposed to the proposed rezoning application. He continued that he had concerns regarding underground parking, increased crime, proposed liquor store, location of garbage container, use of bottle depot centre, and radio frequency interruption due to lighting around the proposed shopping centre.

<u>Brad Hall, 10477 – 156 Street,</u> was in attendance and commented that he is opposed to the proposed development. He stated concerns regarding loss of view, electrical services to the area, meaning of GVW rating for entrance to shopping complex, and width of the proposed 156 Street underpass.

<u>Bill Reid, #35 - 16888 – 80 Avenue</u>, was in attendance and noted had a similar application in the Cloverdale area had received 100% support from community, but he noted that traffic along 104 Avenue is a problem.

<u>Representative</u>, <u>Starbright Educare Daycare</u>, 15515 – 104A Avenue, was in attendance and commented that she is a daycare owner across the street from the proposed development. She continued that she had concerns regarding safety of children in the area, increased traffic, truck traffic, and proposed liquor store in close proximity to an elementary school.

Mike Burton Brown, Architect, was in attendance and commented that the issue of the liquor store is an expected element in shopping centres and is well run with strict guidelines. He continued that well-designed, well-lit underground parking is now a preferred feature of shopping centres. He added that there had never been radio frequency interruption relative to lighting in the area and that garbage containment centres would be well designed and equally spaced along the development featuring walls and gates. He noted that the proposed underpass was not a factor in their choice of this location of a shopping centre.

Jane Farquson, Bunt & Associates, was in attendance and commented that the project is not expected to generate 800 new vehicle trips and it is expected that 40% to 45% of pass-by traffic already on 104 Avenue would stop to utilize the services at the proposed development. She noted that the 500 to 550 net trips are not new trips but redistributed trips that could potentially utilize the shopping centre. She added that this would not increase traffic and would have a small impact on 104 Avenue. She continued that 156 Street is an arterial road and the underpass the City has recently decided to construct in 2008 has been on the Major Road Network Plan for many years.

She stated that the development is not proposed to develop a raised median on 156 Street, but such a median may be installed at the construction of the overpass where traffic volumes are expected to increase on 156 Street.

She continued that the Traffic Impact Study noted that without this development proceeding, there is already an existing street congestion on 154 Street with the south bound left turn backing up and at 104 Avenue and 160 Street.

She added that this demonstrates to the City the need for a 156 Street underpass now. She noted that the proposed underpass would change traffic patterns in the development and across Highway 101, relieving congestion on 104 Avenue. She calculated that 200 to 300 vehicles would be removed from 104 Avenue and that the future development of the South Fraser Perimeter Road would affect 104 Avenue, taking substantial amount of traffic, including truck traffic. She noted that the City is proposing to widen 156 Street in the Ten Year Servicing Plan and the focus of the Gateway Project is to improve cross highway access and capacity of interchanges. She stated that she would anticipate congestion at 104 Avenue and 156 Street intersection would have a positive impact on traffic in the area. She added that the developer would provide traffic signals at 157 Street and 104 Avenue and sidewalks providing additional protection for pedestrians.

<u>Peter Hume, Hume Consulting,</u>, was in attendance and commented that a market study prepared in May of 2005 had been submitted to Planning & Development. He continued that the four major components of a neighbourhood shopping centre include liquor store, grocery store, video store, and drugstore.

<u>Joyce Boles, 10467 – 156 Street</u>, was in attendance and commented that there is a grocery store currently located at 104 Avenue and 156 Street. She noted her concerns regarding increased traffic and property devaluation in the area.

George Bilodeau, 15592 – 104A Avenue, was in attendance and commented that he had concerns regarding traffic signals on 104 Avenue and added that 104A Avenue should be a through road.

<u>Fred Harris</u>, 5689 – 125A Street, was in attendance and commented that he owns Lot 3 on the Semiahmoo Trail which backs onto the Trail. He continued that the actual walking path is 180 feet away from his property; the area is heavily treed and cannot be seen from his property. He noted that staff suggested a development variance permit and he added that he would like a 25 foot setback and the heavily treed parkland effectively screens his property from the Trail.

<u>Larry Ramsell, 14391 Crescent Road</u>, was in attendance and commented that he had concerns regarding the lack of pedestrian crossing at 144 Street and Crescent Road.

Kevin Anstey, 3356 - 145 Street, was in attendance and commented that he had concerns regarding the impact of the proposed setback on his property. He added that nearby property owners have an issue with the impact of the setback on their properties as the park is so much wider behind their properties and heavily treed. He proposed that the 10 meters adjacent to their properties remain and be removed from the Trail. He raised concern regarding maps attached to the Public Hearing Notice and area of impact.
