The purpose of the redesignation and rezoning is to permit the development of approximately 91 small lot single family dwellings and 83 townhouse units and to slightly modify the boundary of the adjacent golf course.

The Notice of the Public Hearing was read by the City Clerk. The location of the property was indicated to the Public Hearing.

Colin O'Reilly, 7869 168A Street, was in attendance and commented that his concerns are not to object the development, but to object to the traffic pattern currently in place that will need to accommodate an anticipated additional 350 vehicles. Presently, the line of sight, due to the steepness of 168 Street, is extremely dangerous. Entering in and out of 168A Street off of 168 Street can be nearly impossible at times. In the winter months, snowfall has crippled the area many times, most recently for as long as three weeks. Traffic lights will not alleviate the concerns due to the steepness of the hill. Two petitions have been forwarded to the City requesting a change to the traffic pattern.

It was noted that there has recently been a traffic study, a copy of which has not been circulated to the speakers.

<u>Linda Campbell, 7810 168A Street</u>, was in attendance and commented that her concerns were with regard to the anticipated increase in the volume of traffic on 168A Street. Making a left hand turn out of 78A Avenue on to 168 Street is often like "taking your life in your hands". An increase of traffic, especially during the rush hours, will back traffic up into the neighbourhood.

Grant Rice, 10378 12A Street, was in attendance and commented on his objection due to the adjustments to the ALR in the application. The application, as it stands, does not meet Policy 0-23. The City's Agricultural Advisory Committee recommended denial of the application on July 10, 2008, based on

non-compliance to Policy 0-23. The ALR boundaries should not be altered for any reason whatsoever.

Information was provided regarding the establishing of the ALR and the ALC and the relevancy of that information as it relates to the application. To make adjustments to the ALR is sending a message that the City is open to land changes; we have to make sure to protect the ALR boundaries.

Copies of a book entitled "Plan B 3.0, Mobilizing to Save Civilization", by Lester R. Brown, was provided to Council.

Bruce Burley, 7799 168A Street, was in attendance to express his concerns regarding the lack of information provided from the City pertaining to the traffic concerns for the area and the alternatives possible to alleviate those concerns. Again it was noted that the concerns of the neighbourhood are not with the development or the ALR swap, but rather the increased traffic flowing through the neighbourhood without any alternative routes to exit from; a problem that escalates during the winter months.

Further concerns included the flooding at the bottom of the hill of 168 Street, whether increased flooding would occur due to the additional roofs and driveways from the development and, due to the present economic slowdown, if there could be some form of completion bond put in place to prevent a stop on development.

<u>Chris Thomasson, 19065 52 Avenue</u>, was in attendance to express her concerns regarding the ALR land swap and her support of the Agricultural Advisory Committee's denial of the application. It was noted that the land swap was based on geography: the land being removed is on a hill and the land being replaced is flat land that can be farmed.

Robert Hammerer, 16877 79 Avenue, was in attendance to address traffic concerns accessing 168 Street off 78A Avenue as well as entering 78A Avenue from 168 Street. 78A Avenue is narrowed due to parking on the street, which makes traffic congestion a real concern.

Councillor Bose expressed concern regarding public open space and how the development fits into policies with respect to maintaining linear parkway.

<u>Clarence Arychuk, Hunter Laird Engineering Ltd.</u>, was in attendance to address some of the concerns that were made regarding the development. It was noted that there are policies and by-laws in place that allow public access through the townhouse development. Background information pertaining to the development was provided.

With regard to the Agricultural Advisory Committee denial of the application, the application was taken to the Agricultural Land Commission, who did provide their approval for the application.
