Ms. Greco was attendance before Mayor and Council to perform a poetry reading as part of the Canada-wide Mayor's Poetry City Challenge Project in support of the League of Canadian Poets National Poetry Month.

## Surrey: A City in Six Parts

1.

Begin with a single tree alone in a grassy field.

Observe the obstinate way its trunk wrenches ever upward, sustained by the very earth it pulls itself from.

Notice the shape of its myriad branches spreading out and open like a waiting hand to cup the rain.

Consider the line of its stance how it reaches for the light the ways it bends around itself, stretching into breeze.

Contemplate the many years the tree has resided here the many dried-up summers it has endured the winter nights it's stood its ground against the cold, in solitude.

Listen to its branches, their tips so fine in green, those many sibilant fingers, rubbing amongst themselves a mystery of whisperings to the sky.

2.

As a single tree can be admired, a forest is to respect. So much more than the sum of its trees, it lives and breathes, holds the soil in its grasp enmeshed in a handshake of intertwined roots.

It is essential, the same way we must hold one another, lean toward the lee, away from the wind.

David Brown's twin sons were born without the gift of sound learned to speak a private finger-talk. Built themselves a tree house where we now have Redwood Park, planted for the rest of us, a forest.

3.

Settlers were drawn here by acres of soil enriched by eons of flooding. The river would open its fan every spring, spread such fine silt, black across the land, a gift for generations, enduring.

4.

Bounded north by a river and westward by sea, both bearing names from faraway times: the mighty, wide Fraser; Cortez's Pacific – remembering explorers, makers of maps.

Our less famous waterways were once used as roads: *Nicomekl* – clicking word – nearly all we know of a people who lived here before.

Nicomekl – gone, as the beavers who built their sturdy dams, homes along those alder-wooded shores.

Nicomekl – people disappeared by a disease, smallpox, a gift they didn't need.

Think of them as you paddle the river with their name, curl your way into Serpentine bend. It is only in remembering that dreams can take root.

5.

Others who came before us, the Kwantlen, Semiahmoo understood the seasons of herring, smelt and salmon recognized when to gather nettles, berries, chanterelles knew the ways of deer and bear, could feel the pull of moon learned to read the warning signs: red tide, a trembling pond.

6.

Crescent Beach serves well as the thumb, invitation for a ride to sea, index finger, Harold Whalley, points out City Centre, Guildford tall-man with its view beyond and over the river, ring man's farm lands make a promise reaching for tomorrow, Hall's and Kensington Prairies extend the span of sturdy reach upward to the rolling plains of Fleetwood and Cloverdale, furrowed in springtime with lines as deep as a palm with fortune blessed. Reach out your hand in greeting: welcome, this is home.

The delegation thanked Mayor and Council for their support of the literary arts in the City of Surrey, reminded everyone of the interconnectedness of Surrey and asked that people try to continue celebrating national poetry month all year long.

Mayor Watts provided Ms. Greco with a framed proclamation and thanked her for her poem.

Engineering (representing an area resident): Clarified the resident has no objection to the land use rezoning application before Council; however, is concerned with the proposed storm sewer layout and questions whether the applicant has provided necessary requirements. Suggested that Lots 3 and 4 would require modification to accommodate amendments for the storm sewer. Expressed concern regarding the possibility of 139 Street being made into a thru road as the proposed grade would be 14 percent.

Staff noted they will continue to work with the applicant during the detailed design phase of the project.

A. Vick, 14107 – 101 Avenue: Supportive of the development but does not believe it is the best fit or use within the NCP; requested Council to consider a higher density to facilitate increased rapid transit options and additional viewscape opportunities.

<u>B. Hennessy, 6077 – 140 Street</u>: Not opposed to the development; requested the applicant consider implementing consistent fencing to serve as a buffer between the new development and his existing property.

S. Anderson, 19460 – 72 Avenue: Expressed concern regarding the current parking. Noted the rezoning would have more impact on the neighbourhood due to the current demand. Commented that with future road widening, the angle parking on 72 Avenue will be substantially reduced causing more congestion. Vehicles are a requirement for the area as there are no viable transit connections in Clayton at this time.

Staff clarified that with the proposed development, for each lot, where there are four units; there would be four parking spaces.

<u>L. Barnett, Barnett Dembek Architects (on behalf of the applicant)</u>: Noted the parking requirements have been met for this site for typical manner houses. The intent for the manor houses is to provide another option for individuals entering the housing market for the first time. The proposed units are smaller, are two levels above grade with unit sizes (including the basement) of 1380 square feet. Are not intended to be multi-family homes but as a stepping stone. The units are 2 bedroom units.

<u>G. Rice, 10378 – 125A Street</u>: Opposed to the application. Commented that the consultation process was flawed; he received a pre-notification and yet individuals residing in the area and community associations were not contacted by staff or the applicant. Commented the residential communities should have been notified due to proposed rezoning, expressed concern that new homes, in Bridgeview are located to this proposed CD Zone. Noted the public notification sent to residents does not contain language to convey the expansion plans. Noted the proposed development is a great impact on the community of Bridgeview.

Council requested staff to provide clarification regarding the expansion plans for the proposal. Staff clarified that a letter did go out. A pre-notification letter went to properties within 100 metres. The Development Variance Permit (DVP) sign was installed on the site and all the necessary agencies were consulted.

Council clarified that the building has been in existence since 1950 and the zones in place at the time did not have any height to them. Staff confirmed the same operator wants to expand their operation. The CD Zone is to allow for 1 building 40 metres in height and the remaining must not exceed 18 metres.

G. Froese, Abbotsford, BC (on behalf of the applicant): The original rezoning request for permission to relax the height requirement from 18 m to 33.7 m went to the Board of Variance on March 14, 2012, the Board ruled the application was outside of their jurisdiction and applicant was referred by staff to Council. The delegation clarified the proposed plant will utilize new technology and will be more of a 'closed system' design to mitigate noise, dust, and comply with regulatory requirements. The applicant clarified the sign board for the proposed Development Variance Permit (DVP) was installed on the subject site 2 – 3 days before the deadline.

Council encouraged the applicant was to speak to the residents regarding concerns raised at today's public hearing.

<u>D. Hebert, Lehigh Hanson (Applicant)</u>: Clarified the company will be operating within the code of practice. This new facility will replace the current facility and will be a closed operation utilizing a wet process (i.e., the concrete that leaves the facility will be wet); there will be a series of exhaust fans which leaves little opportunity for dust. The project is a \$7M investment in the City of Surrey, allowing Leigh Hanson the ability to grow the company as Surrey grows.

Mayor Watts clarified for members of the public that the old building will be removed and replaced with a new more modern facility with superior reclamation equipment.

It was noted the parameter road will be developed which will greatly mitigate / reduce truck traffic and noise levels. The proposed project is not an amalgamation; there is only <u>one</u> lot involved, which is the primary business.
