1. Doors Open Surrey Event

Jessica McGuire, Community Service Assistant - Diversity and Youth Services with Sireen El Nashar, member of the Diversity and Inclusivity Committee were in attendance before Council to discuss the "Doors Open Surrey Event."

- The delegation explained the purpose of the Doors Open Surrey Event is for citizens to discover and explore Surrey, from the unique historic sites, parks, places of worship and architecture to the art exhibits and hidden gems. During the event, over 30 venues in the North Surrey and Newton area will be free and open to the public; venues will offer activities, guided tours, giveaways, guest speakers, and entertainment. - Volunteers are needed for Saturday, June 23rd between 10:30 am 4:30 pm at over 30 Doors Open Venues.
- Another aspect of the event is a geocaching challenge; geocaching is a real-world outdoor treasure hunting game where players try to locate hidden containers, called geocaches, using GPS-enabled devices. When geocaching, participants use a Global Positioning System (GPS) and written instructions to locate hidden "caches" as part of a team or on their own. Once participants find the location of the cache using a GPS, they must decode written instructions to discover where the cache is hidden. As participants explore Surrey during Doors Open they can discover hidden caches and prizes will be won when caches are found.
- Event marketing will be achieved through several platforms such as: web, print, bus advertisements and through partner organizations.

Council thanked the delegation and Councillor Villeneuve for making the Doors Open program a reality and commended the bold marketing campaign.

The report also seeks Council approval to forward a request to the Provincial Government to transfer sufficient funding to the City of Surrey to cover the costs of the work associated with administering the proposed by-law since such work falls under the mandate of the Province, but the Province is not undertaking the work to a satisfactory level, which is impacting those residents in the Province who rely on rental accommodation for their shelter.

Councillor Villeneuve explained the significance of implementing a Standard Maintenance By-law was first brought to the attention of the City during a presentation made by the Association of Community Organizations for Reform Now (ACORN) during a Social Planning Committee meeting. The group gave a compelling presentation about the difficulties tenants have going through the *Residential Tenancy Act*. The Committee was astounded the process was so laborious and that at the end of the process, the *Tenancy Act* does nothing about enforcement. The City of Surrey will use the "Standard of Maintenance By-law" as a tool to insist all tenants live in safe dwellings; the by-law has fine system ranging from \$200 - \$10,000.

Council thanked the Social Planning Committee and Councillor Villeneuve for all their work in bringing to light this very important initiative and noted it is regrettable that the CoS is dealing with this issue, as it should be addressed at a Provincial Level.

The Notice of the Public Hearing was read by the City Clerk. The location of the property was indicated to the Public Hearing.

<u>S. Hall (nee: Ray) 310, 9765 – 40 Street – Fraser Gate Strata</u>: Reported the developer is actively advertising units for sale in a local newspaper and by posting a notice on the subject property fronting Fraser Highway. The delegation expressed concern regarding the following: noise, tree removal/damage, wildlife corridor disruption, drainage, encroachment on existing residential units, percentage of renters versus owners, and insufficient public notification period.

Staff clarified that the property has been designated as multi-use residential for over 20-years under the Official Community Plan (OCP).

<u>A. Vick, 14107 – 101 Avenue</u>: Asked if consideration could be given to increasing the density of the proposed property given the proximity to the SkyTrain.

<u>E. Dennis, 8266 King George Boulevard</u>: The delegation was a previous resident who vacated the property and noted that the developer has not adequately compensated her for vacating. The delegation requested the matter of outstanding compensation for previous residents be added as a covenant prior to Council granting final approval of the development application.

<u>David Porte, Developer</u>: Addressed concerns raised during the public hearing as follows: 1) the project complies with all setbacks; 2) there are no variances; 3) the building will be strata titled, therefore the ratio of rentals / owned units will be up to the elected strata council.

Council asked for clarification on the proposed new tree plantings. The Landscape Architect clarified the cedar hedge will be retained, with respect to the existing trees, due to the building location, approximately 32 trees will be removed (10 of which are within the hydro-corridor right-of-way). The delegation further clarified that 132 trees will be planted along the existing cedar hedge to serve as a buffer.
