Karoway, 10226 – 157 Street: Expressed concern regarding the following: 1) traffic safety in the area, 2) impact on school parking, 3) potential for traffic congestion, 4) parking for construction workers and on-street vehicles, 5) loss of drop off zone at the school, 6) the increased traffic on 156 due to the underpass, 7) how garbage removal will be managed for the proposed development.

Staff explained Harold Bishop Elementary School is in close proximity to the proposed development but clarified that the widening of the lane will assist with traffic flow and that the applicant will be dedicating a portion of the lane along their site; the school will not be negatively impacted.

In response to the garbage removal concern expressed by the delegation, staff clarified that the garbage would be collected in the underground parking of the development and that access will be from 103A.

<u>K. Karoway, 10226 – 157 Street (Harold Bishop Student)</u>: Expressed concern regarding the safety of staff, students, and faculty.
