<u>V. Gunawardana, 141 Street - 103A Avenue</u>: The delegation expressed the following concerns: 1) The Application for 16 townhouses was approved with a Public Hearing; at which time, it was referred to staff to address concerns raised during the meeting, and 2) the Project is now adding 5 more homes making it 21 in total and there was no Public Hearing, 3) the corner lot is not in the keeping with the context of the neighbourhood, and 4) proposed tree removal associated with the development.

Staff, in response clarified that the subject site did have a Public Hearing on November 28, 2011 and staff prepared a subsequent report at the request of Council. Some of the issues raised during the Public Hearing were surrounding the completion of 103 Avenue and the remainder lot (which is the subject lot in today's Application). Council considered a Corporate Report on February 6, 2012 and at that time gave third reading and final adoption of the Development Permit.

Mayor Watts explained that based on the information provided in the staff report, Council was able to give the application third and final readings.

Council requested staff to provide the delegation with the documentation and the minutes of the Public Hearing pertaining to the lot.
