In response to a question from Council regarding how new information received from the Biodiversity Conservation Strategy, Fergus Creek Watershed Plan and feedback from the Agricultural and Food Security Committee will be incorporated into the new Official Community Plan (OCP); staff, in response noted that the OCP is really a living document and that over the course of the year, it is updated from time-to-time based on changes that arise. Once the Biodiversity Plan is approved by Council it will be rolled into the OCP and as the other pieces identified are completed and approved by Council they will also be rolled into the OCP.

Staff addressed further concerns raised by Council (on behalf of the Cloverdale Community Association) as follows:

1) Parks, park lands, and how the City will acquire properties in Cloverdale.

Staff in response noted that the Parks Department has a master plan with criteria based on the number of acres of parks per number of resident's ratio; however, due to land speculation, the document is not made public. The Biodiversity Study will also influence the park acquisition plan and will help respond to the questions,

2) Mound Farm Park is subject to a long-term lease agreement.

Staff in response noted that there was a master plan prepared 3 years ago however it was not implemented to-date due to biodiversity sensitivities. At this point in time, the park is preserved but is not open to the public

3) Light Rapid Transit (LRT) stations and the agricultural land.

Staff clarified that the OCP identifies as per the TransLink Study completed by the City of Surrey. Staff has setup a meeting with key individuals from TransLink regarding Fraser Highway and Highway 15. It has a few components that TransLink needs to address with the Agricultural Land Commission (ALC) as it requires a park and ride and other amenities and it resides on Agricultural Land.

Staff further clarified that each development application is judged on its own merit, the OCP is a guideline for the density of Town Centres. All amendments to the OCP would have to come for a Public Hearing.

Council noted that in creating the OCP extensive Public Consultation that was conducted, involving over 10 presentations to Council as well as interagency consultations. As a result, all members of the Community, and various stakeholders have had a good opportunity to participate in the process. Decisions made as part of the plan are made with the best long-range interests of the Community in mind.
