<u>D. Hirabe, Hunter Laird Engineering Ltd (Consultant)</u>: The Agent clarified that there is a pedestrian walkway that will be constructed in support of the development and there are trees that will need to be removed to accommodate the pedestrian walkway and to facilitate the construction of the development. Trees on Lots 5 & 6 will be impacted due to the construction of the road; the trees located on the North Side of the property will be impacted to facilitate construction work. The Consultant noted that the Applicant worked with the

neighbours and the City of Surrey Arbourist and it was agreed the subject trees cannot be retained.

<u>Concerned Resident</u>: The delegation expressed concern regarding the impact on on-street parking and how additional vehicles will be accommodated. In response, staff noted that the proposed development will have double-car garages with the ability to park two vehicles in front of each garage. Staff further clarified that vehicles will be ticketed and towed if they are blocking driveways.
