B. DELEGATIONS – PRESENTATIONS

1. Elizabeth Model, DSBIA, Better Transit and Transportation Coalition File: 8710-01; 0550-20-10

In attendance before Council to provide information on the upcoming transportation plebiscite and to highlight the benefit to Surrey with respect to the Mayor's Transportation and Transit Plan.

The following comments were made:

- The Better Transit and Transportation Coalition is a diverse group who support the Mayors' Council Transportation and Transit Plan.
- The proposed Transportation and Transit Plan will fund and expand transit and transportation improvements throughout Metro Vancouver.

- A plebiscite will be held from March to May 2015, whereby all members of the public throughout Metro Vancouver will have an opportunity to voice their opinion and vote on the Mayors' Council Transportation & Transit Plan.
- The Coalition will work with the Mayors' Council to provide public education on how important the upcoming plebiscite is. The goal is to support the Mayor's and the transportation plan overall and to ensure the people of Vancouver and Metro Vancouver understand the benefits of the plan and to vote in favour of it.
- The group is developing a communications and media plan to mirror the Mayors' leadership group to communicate the positive outcomes of a "Yes" vote.
- The delegation noted that some of the key benefits for Surrey would include:
 - o 80% increase in NightBus services,
 - o 30% increase in HandyDART Services,
 - o Improvements to the existing Frequent Transit Network (FTN) on busy routes e.g. KGB, Scott Road, Fraser Hwy,
 - o Expansion of FTN on new corridors, e.g. 64 & 84 Aves,
 - Expanded coverage in communities, e.g. Clayton, Morgan Creek, Anniedale; and,
 - o New Pattullo Bridge

The applicant is seeking to rezone the property from One-Acre Residential to Half-Acre Residential in order to subdivide into 2 half-acre residential lots which will front 164 Street in a panhandle configuration.

The Notice of the Public Hearing was read by the City Clerk. The location of the property was indicated to the Public Hearing.

N. Hofoss, 90 Avenue & 163 Street: The delegation expressed the following concerns: 1) the placement of the proposed development would be abutting her backyard; and 2) the proposed rezoning will negatively impact the value of her home.

<u>I. Scibor, 90 Avenue & 163 Street</u>: The delegation expressed the following concerns: 1) the proposed home will be situated in close proximity to her backyard and fence causing the viewscape to change, 2) potential decrease in her property value, and 3) the rezoning is not in keeping with the neighbourhood context.

Staff clarified that the existing house is close to the street and the new house is proposed to the rear of the lot with a minimum 25 foot setback to the western property line.

<u>H. Nowak, 90 Avenue & 163 Street</u>: The delegation noted that when he purchased his home he was told there was a buffer zone between residential and agricultural, the proposed development will greatly reduce that buffer.

R. Samus, 90 Avenue & 163 Street: The delegation expressed the following concerns: 1) the impact the development will have on the community, 2) being located in an A-1 zone, it was his understanding his property would have a buffer across from the ALR that would not change, and 3) the proposed project will encroach on the existing properties in the vicinity.

M. Bola, President, Cloverdale Community Association: The delegation expressed the following concerns: 1) the project is already 100% tandem and the request to have the parking amended is not acceptable to the Community Association, 2) street parking is already fully allocated therefore additional street parking options would be limited, 3) there is no reason to increase community parking issues further, 4) the Community Association does not support the proposed tandem parking in the area; and 5) no public notification letter was sent by the developer to the Community Association regarding the project.

Staff clarified that an increase in lot coverage from 31% to 41% is a text correction only and that the original proposal should have been 41%; what is before Council tonight is simply a housekeeping amendment.

M. Dembek, Barnett Dembek Architects Inc. (on behalf of the Applicant): The delegation clarified that the intent of the Application is to allow for an additional flex-room space for the Units located on 188 Street and noted that the tandem arrangement is not going to be amended.

Council requested clarification regarding the comments made by the Applicant that the Application will not change the form of the development. The delegation clarified that the original garage configuration was indoor and tandem, in the proposed it will be a single garage with 1 parking spot on the driveway.

The delegation further clarified that there is no net loss of existing parking; the proposed development meets the parking requirements. The garage is a standard size.
