proposing to subdivide into 6 single family lots.

The Notice of the Public Hearing was read by the City Clerk. The location of the property was indicated to the Public Hearing.

R. Hsieh, 155 Street & 109 Avenue: The delegation expressed the following concerns: 1) the proposed alleyway on the site plan encroaches on his property as it will be only five metres away, and 2) the delegation requested Council to consider an alternative alignment to improve resale options.

Staff, in response to a question from Council noted that the delegation's property is located east of the proposed site. Staff further noted that the proposed lane will serve the neighbouring property only.

M. Kompter, Agent (on behalf of the Applicant): The Agent clarified that the plan before Council is only a design concept and there are other options available should the delegation decide to subdivide his property. The Agent further noted that the lane is not required for the application before Council tonight and that the alternative proposal suggested by the delegation would reduce the proposed development by 1-lot; any deviation from the proposed plan would be economically unviable.

The proposed store is more retail in context and the applicant has been working closely with staff to achieve a complementary building form and landscape design. The company takes pride in their environmental track record, and are industry leaders in the transport and safe storage of materials and supports many local charitable organizations.

M. Bernhardt (Franchisee, Great Canadian Oil Change): The delegation noted that the company is Canadian owned and operated. The organization prides themselves on the quality of their retail location and high standards. Materials collected are recycled in a safe and environmentally friendly manner. The location will provide several well paying full-time jobs with benefits for local residents.

The Social Planning Committee felt it was important to emphasise the issues of transportation, housing, income and support. Responsibilities were split into what municipalities can do and also what would be appropriate at a Provincial Level. The result was the Poverty Reduction Coalition along with a number of funding agents designed to keep the initiative going. The Surrey Libraries have been a great supporter of the programming by providing free of charge brochures and information.

British Columbia is one of only two provinces that do not have a Provincial Poverty Reduction Plan. The City and Council will continue advocacy to eliminate the Refugee Transportation and Pre-Medical Screening Loans which are an unfair burden which make it difficult for new immigrants to move forward and become inclusive members of the community.

Councillor LeFranc thanked Mayor and Council for their leadership in producing a comprehensive plan. The Somali Women's Project has been a success, as is the Community Leaders Igniting Change - which is a program that will carry out projects to lift communities out of poverty. The Housing First Initiative means that we are housing those homeless, and those difficult to house before asking to give up their addition issues. Councillor LeFranc noted that there are huge investments, in the form of grants, available from both provincial and federal governments to make further inroads in poverty reduction.

Mayor Hepner thanked Councillors Villeneuve and LeFranc for the work done on this important initiative.
