PURPOSE:

The applicant is seeking to rezone a portion of the site from One-Acre Residential Zone to Single Family Residential (13) Zone. The applicant is proposing to subdivide the site into 29 single family small lots; 1 lot to remain zoned One-Acre Residential and retain the existing house and accessory buildings; 2 park lots that will provide pedestrian connectivity over the Fortis right-of-way; and one park lot

to be conveyed to the City for riparian area protection.

In addition, a Development Variance Permit is being sought to reduce the minimum side yard on a flanking street setback from 7.5 metres (25 ft.) to 4.1 metres (13 ft.) in order to accommodate the existing accessory building on the One-Acre Residential lot.

The Notice of the Public Hearing was read by the City Clerk.

<u>D. Swanson, 161 Street and 78 Avenue:</u> The delegation expressed concerns regarding parking and requested that construction access to the site be provided from 80th Avenue.

<u>W. Shi, 78 Avenue and 162 Street:</u> The delegation spoke in opposition to the proposal citing reduction of green space, increased noise activity, decreased privacy and negative impact on property values.

<u>Resident:</u> The delegation spoke in opposition to the proposal citing the increased density and increased noise activity.

<u>Resident:</u> The delegation questioned the development timeline for the remaining one-acre lot.

<u>D. Jack, Surrey Environmental Partners:</u> The delegation expressed concerns regarding the removal of trees from the subject site and the double counting of riparian setback area as outdoor amenity space.

<u>Resident:</u> The delegation spoke in opposition to the proposal citing increased density and traffic volume along 78th Avenue. The delegation suggested implementing a catwalk instead of a thru road along 78th Avenue.

M. Helle, Coastland Engineering & Surveying Ltd. (Agent on behalf of the Applicant): The Agent provided an overview of the proposal and spoke to construction access, the 78th Avenue Road connection, density and tree retention.
