Staff noted that three new elements will be added as follows:

- 1. Truck Parking Environmental Protection Policy the new policy will ensure water quality through all sites by way of water treatment separators; additionally each site will be assessed on its own merits. For sensitive unconfirmed aquifers the applicant will be required to hire an independent consultant and work with staff to mitigate any identified issues.
- 2. Truck Parking Facility Permit will streamline the process, eliminate the requirement of a building and servicing of the site in terms of water and sanitary and DCC fees. The City will continue to allow temporary use permits for gravel surfacing until a permanent use can be determined. There are a number of farmers who need to supplement their income on the off season; City staff has worked with the ALC to determine the appropriate number of vehicles allowable on site, subject to there being a farm operation on the site and a residential dwelling.

3. **Elimination of Unauthorized Truck Parking Sites** - whereby allowing Bylaw Enforcement Staff to implement fines and work with residents to encourage suitable sites and establish a program to address illegal repairs on the sites.

Council thanked staff for the report and requested clarification for monitoring and environmental enforcement. Staff noted that the Bylaw Department will be reviewing their staffing requirements in consideration for next year's budget.

# 1. Seniors Elder Bank Program - Pilot Project

File: 0620-20

The Mayor announced that the City of Surrey received a cheque for \$300,000 in support of the Elder Bank Program on April 18, 2016.

The pilot project will reach out to seniors within the community and capture their wealth of knowledge in a Triple "E" Elder Bank that can be accessed by the general public. Triple "E" stands for expert, entertainer and educator and the Triple "E" Bank will collect as many participants who want to come forward and offer their experience to the community. It will represent an opportunity for seniors to tell their story and offer advice to younger people that have a similar interest or a career they wish to pursue.

The City of Surrey will match \$300,000 worth of funding from the provincial government over three years for this pilot program. A new Elder Coordinator position will be created to develop and implement a comprehensive municipal strategy of engagement that is evidence-based, embedded within current and new programs and partnerships, and most importantly driven by the vision of seniors as an essential community resource. Two key programs within this coordinated approach are the development of an Elder Bank and the implementation of an oral history project.

Mayor Hepner noted that the program is exciting and provides the City of Surrey with an opportunity to utilize talent that already exists and that staff will soon begin the process of recruiting volunteers for their expertise in a number of arenas.
