1. **Neal Aven, Urban Forestry and Environmental Programs Manager**

In attendance before the Commission to provide an update regarding hazardous tree removals required near Stewart Farmhouse.

The following comments were made:

- Tree removal work is taking place near the Stewart Farmhouse at Elgin Heritage Park. Elgin Heritage Park is a 23 hectare park located on the banks of the Nicomekl River in South Surrey that was recently evaluated for tree hazards by a qualified Tree Risk Assessor. Based on the evaluation, dead or structurally compromised trees with a high likelihood of falling into areas occupied by people or facilities will be removed. All the work complies with Environmental Best Management Practices and Environmental Regulations.

Members of the Commission noted they would like to see the City plant new trees in place of the ones that are being removed. Staff clarified that the City has a progressive program to plant approximately 5,000 shade trees on City property each year.

Staff provided images of their top favourite 20 heritage buildings that are as old as 145 years old. Many of the buildings are protected by a Heritage Revitalization Agreement, listed in the Heritage Register, or are protected by a Heritage Designation Bylaw. (b) **Heritage Strategic Review Implementation Plan Update - Potential Topics for Strategic Planning Session**

- The Heritage Strategic Review, approved in 2010, included a five-year Implementation Plan that identified work plan priorities from 2011-2015. The Commission has allocated funds to hire a Heritage Consultant to lead a strategic planning session and prepare an update to the Heritage Strategic Review Implementation Plan in the fall.

The following comments were made:

- Staff requested that the Commission provide suggestions for potential topics for inclusion in the strategic planning session scheduled for this fall. Some topics the Commission may want to consider include the use of the Commission's restricted funds, the process and policies for the evaluation and addition of properties to the heritage register, future priorities for the City's heritage plaque and storyboard programs, future considerations for heritage site recognition in Surrey, and the Commission's role and mandate with respect to outreach activities.
- The Commission agrees with staff that a review of the Task List through strategic planning is necessary in order to refresh the Commission's mandate. They would like to see the Strategic Planning Session agenda ordered in a way where the big picture could be brought forward first, with smaller ideas subsequently.

The Commission agreed to discuss and refresh their mandate in order for the new Commissioners to have a clear direction as to the strategy moving forward.

(c) **H.C. Major House (12876 Crescent Road) Heritage Revitalization Agreement (HRA) Application**

Staff noted that the purpose of this report is to inform the Commission that an application was submitted for a Heritage Revitalization Agreement for the H.C. Major House at 12876 Crescent Road.

The H.C. Major House was built in 1920 and is listed in the Surrey Heritage Register. A development application was submitted by the owner for a subdivision and Heritage Revitalization Agreement (HRA). The applicant proposes to protect the H.C. Major House through the HRA, build a second dwelling on the subject site and subdivide the property to adjust the lot line, which will address the existing encroachment issues into Crescent Park.

City staff will prepare the conservation plan for the House and complete a Statement of Significance (SOS). The SOS will cost an estimated \$1,720.00 and require a heritage consultant. The completion of an SOS will make the H.C. Major House eligible for addition to the Canadian Register of Historic Places.

Pie in the Plaza is a public festival to celebrate food and farming in Surrey. The event will be fun and educational and include a mobile petting zoo, seed planting, live music, food trucks, food and craft vendors, games, and interactive informational displays and activities with community organizations. The event will feature BC's largest blueberry pie.

Pie in the Plaza is a new initiative of the City of Surrey's Agriculture and Food Security Advisory Committee (AFSAC) and Planning and Development Department. The agricultural awareness event, which replaces the Flavours of Surrey event, will be held on September 17, 2016 in Surrey Civic Plaza.

Commissioner Evans, Hol, Priddy, and Councillor Woods volunteered their time to participate in this year's Pie in the Plaza event. Funds will be allocated from the SHAC Unrestricted Reserve for the purchase of heritage candy, prizes, and display items.
