#### B. DELEGATIONS

1. Raj Singh Toor, Vice-President, Descendants of the Komagata Maru

**Note:** Memo regarding the City's Commemorative Street Naming Policy and Practice has been circulated for information.

The delegation was in attendance to request that the Commission consider supporting the renaming of a Surrey street in memory of the passengers of the *Komagata Maru*. The *Komagata Maru* was a ship with 376 British subjects that was denied entry into Canada on May 23, 1914. The delegation provided an overview of the history of the Komagata Maru episode and noted that the Provincial and Federal governments have both apologized for the incident.

The delegation requested that the City of Surrey consider naming a street in honor of the *Komagata Maru*, noting that the memorialization is appropriate for Surrey due to its large South Asian population.

In response to questions from the Commission, the delegation provided the following information:

- The delegation has not met with staff regarding street naming policies in Surrey prior to this presentation.
- The delegation would be interested in other options besides renaming a street.

• While there is a memorial in Vancouver, a large percentage of BC's South Asian population lives in Surrey, making Surrey an appropriate memorial location.

The Commission noted that the City has a policy regarding street naming and that other memorial options may be available.

The Commission recommended that the delegation meet with Parks, Recreation and Culture staff to further discuss the matter, including other options that may exist, and requested that staff provide a report following the meeting.

- New forms of heritage signage should always be considered.
- Different levels and forms of heritage signage can help identify historical locations all over the city.
- Heritage inspired utility wraps could be considered, as they promote or identify heritage as well as provide anti-graffiti protection.

In response to a comment from the Commission, staff advised that BC Hydro has granting opportunities for utility wraps and that the wraps are not prohibitively expensive to implement.
